8. Treasurer's Report -Lorraine Vail for Jan Albrecht

OLLI's Financial principles:

- Council adopts a balanced budget every year
- Any excess money adds to our cash balance (savings)
- Budget maintains a cash balance of 35% of annual expenses
- 10-year forecast model is used to ensure long-term viability
- When needed, member fees are raised to keep up with rising costs, balance

the budget, and/or to restore cash balance to target.

For 2018-19:

All categories of income were achieved

Income was greater than expenses

Because of "unusual" expenses, such as the increase in hours of staff and fundraising expenses), the savings account was drawn on.

Osher endowment, originally \$2 million, has now grown to \$2.6 million Legacy fund balance is \$18,800

We have one of the lowest membership fees in the country (and mostly free parking) Budget outline: Income: 59% from member fees, 30% from Osher endowment earnings, 8% from Annual Fund, 3% from sponsors and community partners Expenses: 58% for office staff/tech support, 21% for operations, 15% for facilities and parking expenses, 6% for member programs Budget is not balanced for 2019-20 due to a lower membership projection and some "unusual" expenses related to the need for alternative venues during the Campbell Center renovation. Membership fee unchanged in 2019-20. 9. Financial Report and Renovation update: Lorraine Vail and Cliff Edwards North building completed (except for moving of member's lounge to that building) Our goal at last year's meeting: SOU will contribute \$169,000 We will raise \$496,500. At last year's meeting we had raised  $\frac{1}{2}$  of this amount. In the last 9 months we raised \$324,000, from more than 800 donors. More than half of these donors are new donors to OLLI. 42% comes from major donors. 2019-20: bids will be opened on June 27. Construction will begin late August/early September. We hope bids will come in under our budget. Presentation of humorous video skits: What we could do without, just in case bids come in high. 10. President's Report – Margaret Pashko This year we reached membership of 2130 making us in the top 15 of the 123 OLLIs in membership. We've had a great deal happening: the 25<sup>th</sup> anniversary celebration throughout the year the ReNewall campaign and the Giving Garden mural 365 courses were taught the Leadership Development and Recruitment program was created **Conversation Connections were begun** the strategic plan continued the outreach to Medford continued we addressed issues concerning class locations for fall 2019 when Campbell Center will be largely unavailable. In the annual member survey the overall satisfaction score was 4.3 out of 5, the same as last year. The survey contained 640 comments. The office staff (Rob Casserly, Carol O'Connor/Paige Jenson, Pauline Black, and Paul Truly) and student workers (Jessica Sambrailo and the IT students) received a 4.7 satisfaction rate. We have 650 volunteers who help to make OLLI function. Communication and Community Outreach: Larry Hunter, chair: oversees catalogue. open house, community lectures, advertising and public relations. Special thanks for Anne Bellegia who contributes a great deal. Curriculum Committee: Sara Brown, interim chair: this year included 209 instructors with 56 of these new to OLLI. Future Space Committee: Lorraine Vail and Cliff Edwards, co-chairs: see report above Funds Policy and Management Committee: George Rice, chair: we reached our goal of \$33,600 for the Annual Fund. The Legacy Fund continues to grow. Landscape Committee: Sandy Hansen: gardens look great

Leadership Development and Recruitment Committee: Susan Stitham, chair

A new committee created with the goal to nurture future leadership. Created Team OLLI, with 21 members attending 4 training sessions.

<u>Member Services Committee</u>: Barbara Klein, chair. High member satisfaction in survey.

Focused on enticing new instructors and courses for the HEC; also worked on clarifying parking process, and social aspects
