ITINERARY

Day 1: March 14, 2019 - Overnight Flight to Japan

Day 2: March 15, 2019 - Arrive at Narita Airport. Following passport control, proceed to the baggage claim area. After you collect your luggage, you will be met by a representative of Jet Vacations who will accompany you to your private motor coach for the transfer to your hotel in Tokyo. Tonight, enjoy dinner at hotel. Accommodation in your Tokyo hotel. (D)

Day 3: March 16, 2019 – Tokyo: Breakfast at the hotel. Full-day sightseeing of Tokyo by private coach with private guide. We begin our discovery as we head to the nearby Imperial Palace, where you'll have the chance to view its beautiful outer garden and start our understanding of Japanese history (past and present). Soon you arrive at Asakusa Kannon Temple, which dates to 645 AD, and is known as the city's most famous Buddhist religious site. Listen as your guide details the temples fascinating history and then admire its idyllic gardens, intricate architecture, and sturdy gates. We will also take a cruise on the Sumida River and glide beneath 12 of the city's many bridges. We will end at the Hamarikyu Garden with some time to visit and free time for lunch. Our afternoon will take us to the trendy Harajuku's Takeshita Street and Omotesando Boulevard for shopping and free time. We will continue to the nearby Shibuya section of Tokyo and the famous "scramble crossing". We will rejoin our coach and return to the hotel. Overnight in Tokyo. (B)

***Tonight we can suggest a evening to the "Robot restaurant and show" for a fun and quirky, modern, Japanese experience. The surrounding Kabukicho-Shinjuku area is filled with wonderful local pubs and restaurants".

Day 4: March 17 2019 – Tokyo (Optional tour to Nikko and Shogun Temple): Breakfast at the hotel. Full day free at leisure to explore Tokyo on your own, discovering the excitement of this city (so many things to do and see) or enjoying shopping in Solamachi for example... OR you can enjoy a full day excursion to the mountain town of Nikko with included lunch. Nikko is located 120km north of Tokyo. It has been a religious sacred place since 8th century when a Buddhist priest founded a temple. There are two shrines and a temple in the center of the area, which were designated as World Cultural Heritage sites in 1999. In this tour, we leisurely walk around these shrines and temple. The Toshogu shrine is the main attraction of this tour. It's a Shinto shrine dedicated to Tokugawa Ieyasu, the first shogun of Tokugawa shogunate in the early 17th century. He is one of the greatest samurai hero's in Japanese history that brought Japan 260 years of peaceful times after a long warring era. It's gorgeous and elaborate carvings and sculptures, decorated all over the buildings, will be a wonderful memory of your Japanese trip. The Rinnōji temple was originally founded in the 8th century by a Buddhist priest, Shodo. It had been the sacred place of mountain worship in Nikko for more than 1,000 years. The Futarasan shrine was also founded by Shodo in the 8th century and has enshrined three sacred mountains in Nikko, Mt. Nantai, Mt. Nyoho, and Mt. Taro. The buildings were constructed by plain woods and have no decoration unlike Toshogu shrine. We will also have the opportunity to visit an authentic, family run Sake house and tasting. Overnight at your hotel in Tokyo (B).

****This evening Carl will endeavor to take all those who want to go via public transportation to the old fish market area or Asakusa district for an authentic "Sushi" dinner and experience... We will stroll the fish market area and small alley-ways lined with lanterns and colorful signs. There will also be an opportunity to see the famous Japanese Kabuki Theatre..... NOTE: This is a "Dutch Treat"

Day 5: March 18, 2019 – Tokyo – Kamakura – Hakone/Mt. Fuji: After breakfast, we travel to Mt. Fuji National Park and Hakone. Weather permitting, we will have great views of Mt. Fuji and visit the "fifth station". Here we will board a cable car for Mt. Komagatake and later take a train ride on the Hakone Tozan railway. There will be free time for lunch. In the afternoon, we will visit the Hakone Open Air Museum, a popular destination in Fuji-Hakone-National Park. The museum houses works of Picasso, Henry Moore, Taro Okamoto and others. This is a stunning museum with the backdrop of the National Park and the mountain range. Dinner this evening is included at the hotel. Accommodation in hotel. **Opportunity this evening to stay in traditional Ryokan style Japanese room and Futon beds! (B, D)

Day 6: March 19, 2019 – Hakone – Nara – Kyoto: Breakfast at the hotel. Bullet Train from Odawara Station to Kyoto Station. Bento box lunch. Transfer to Nara & sightseeing by private coach with private guide. Immerse yourself in Japanese history and culture, during this exploration of the temples, shrines and attractions found in the country's former capital city of Nara. Discover this historically significant capital, first established in the 8th century, as you admire its wealth of important religious sites and the one-of-a-kind deer park, nearby. The city of Nara was founded in 710, when it was designated as the country's first permanent capital. Nara, or Heijo as it was then known, was home to many of the most important Buddhist monasteries in the then-nascent Japanese empire, which made it a key center of political and religious power. As Nara's power and influence grew, the city became a threat to the government, leading the country's rulers to move the capital to Nagaoka in 784. Despite this shift in fortunes, Nara retains a wealth of important historical sites, including some of Japan's most important Buddhist temples. Stop by Nara's Todaji Temple to start your trip. This magnificent edifice, constructed in the 8th century, is among the country's most important religious buildings. Explore the temple's Daibutsuden (Great Buddha Hall), one of the largest wooden buildings in the world (awesome), along with its immense bronze Buddha statue, which are just some of the treasures to be found in this incredible attraction. Continue your Nara trip with a visit to its famous deer park, a unique 1,250-acre preserve where more than 1,000 tame deer freely roam. Admire these gentle creatures as they graze and wander the park, and stop to purchase special deer food, which the animals will gladly eat from your hand, if you wish. Finish the day with a visit to Shoun-in Shogunzuka Seiryuden for the most amazing views over the city of Kyoto, on your way back to the hotel. (B, L)

Day 7: March 20, 2019 – Kyoto – Kinkakuji – Ryoanji - Nijo: Breakfast at Hotel. After breakfast, meet your guide at the hotel for a departure to Kinkakuji by private coach. Kinkakuji, also known as the **Golden Pavilion**, was originally built as a retirement villa for the Shogun. After the death of Shogun Yoshimitsu it became a Buddhist Temple at his request, and is now one of Kyoto's most famous temples, with its top two floors completely covered in gold leaf. After visiting Kinkakuji, we will take you to Kiyomizu temple and strolling around the nearby Sannenzaka area with small shop and can suggest Okonomiyaki for your lunch on own. After lunch we take you by coach to **Nijo Castle**. Nijo Castle was built by the founder of the Tokugawa Shogunate as the Kyoto residence of the Shogun and is surrounded by stunning gardens. The ornamental building was completed in 1603 and is well known for its Momoyama architecture, decorated sliding doors, and 'chirping' nightingale floors. Later enjoy a famous Tea Ceremony in the old town district of Gion noted for the famous "Geishas" or entertainers. Return to the hotel for a free evening or book and optional **Geisha/Maiko Kaiseki (multi course) dinner – It is equivalent with western "Haute" cuisine**. Overnight in Kyoto. (B)

Day 8: March 21, 2019 – Kyoto – Osaka: Breakfast at the hotel followed by the morning at leisure to discover the city. ***We would like to suggest for you free time to enjoy a walk of the "Philosopher's Path" from Ginkakuji (Silver Pavilion) to Nanzenji Temple. A lovely walk following the stream. In the afternoon, we visit Osaka and its Castle. This massive stone fortress and architectural marvel, the Osaka Castle sits, on a stone rampart above the city. Built from enormous stone blocks starting in 1583, the castle also features displays with relics of old Osaka and the Toyotomi family that originally erected the castle. Then we move on to Shinsaibashi. This tour is for those who not only want to see the neon signs, but also dive deeper into the Japanese local scene. You will be informed on the basics of hostess clubs, host clubs, youth fashion and hangout areas, and even the Dotonbori entertainment area. Stroll along a local market called Kuromon-ichiba, which has a unique history related with puffer fish. Osaka is famous for its soul food such as takoyaki, octopus dumpling. Hibachi "style" Farewell dinner at the Riuri restaurant in the Shinsekai quarter. Overnight in Kyoto. (B, D)

Day 9: March 22, 2019 – Departure: Breakfast at the hotel. Transfer from Osaka to Tokyo for your flight back to the USA. (B)

6 DAY – 3 NIGHT PRE EXTENTION TO SOUTH KOREA

Day 1: March 10, 2019 – Late Night Departure: Non Stop flight to Seoul.

Day 2: March 11, 2019 – Flight to South Korea.

Day 3: March 12, 2019 – Arrival in Seoul: Incheon - Seoul: Upon arrival at Incheon airport, proceed to baggage claim and after clearing customs, meet your local tour escort. Hotel check-in and rest! Later, we will meet for a nice lunch (Korean buffet) and start on a panoramic tour of Seoul. See the Presidential Blue House, the symbol of Cheongwadae (known to westerners as the Blue House or the Presidential residence). As the Blue House represents the country of Korea, the blue tiles and the smooth curve of the roof represents, the beauty of Korea. Visit Deoksugung Palace, dating back to the Joseon Dynasty located in Seoul's Jung-gu quarter. See its fascinating progression through history, and experience the hanbok rental (traditional clothing). Visit Insadong street, one of the most memorable attractions in Seoul that represents the focal point of Korean traditional culture and crafts. Stores in Insa-dong specialize in a wide variety of goods that can only be purchased or seen in Korea: hanbok (traditional clothing), hanji (traditional paper), traditional teas, pottery, and folk crafts. Visit the Namdaemun shopping Market, the largest traditional market in Korea where you will find shops selling various goods. All products are sold at affordable prices and the stores in this area also function as wholesale markets. After dinner on own, visit N Seoul Tower Namsan (Mt), the best view point location from which all can gaze down on the whole city of Seoul. Transfer to the hotel and overnight. (L)

Day 4: March 13, 2019 – Seoul – DMZ - Seoul: After Breakfast at the hotel. Meet your guide in the hotel lobby and set out towards Imjingak Park (Please bring your passport). Visit Imjingak Park and see the Freedom Bridge, the 3rd Infiltration Tunnel, the Dorasan Observatory, Dorasan Station, the Unification village. ** Korea is the only divided country in the world. It means DMZ is the only place that you can experience this situation. Do not worry, the DMZ is not dangerous at all and you will learn first-hand what happened at these locations and what's happening in Korea. Lunch is on own. As you make your way back to Seoul, see the Cheonggyecheon river. The river is a 5.84km-long stream flowing from Gwanghwamun to Dongdaemun. Tonight we enjoy a cooking demonstration and class to experience Korean food from the traditional to the contemporary with included dinner. Transfer to the hotel and overnight. (B, D)

Day 5: March 14, 2019 – Seoul - Yongin - Suwon: After Breakfast, we set out to visit Minsokchon, a folkloric Village located in Yongin, a suburb of the capital city. It is a traditional Korean version of Universal Studio. Enjoy walking in the recreated village where traditional Korean lifestyle is preserved and exhibited. In the Folk Village, various lifestyles prevalent during the Joseon Dynasty can be seen. You will enjoy traditional Korean performances (weather permitting). Lunch is on own. In the afternoon, travel to the walled city of Suwon in the provincial capital of Gyeonggi-do, and visit the Hwaseong Fortress. On the way back to Seoul, visit Myeong-dong street, famous for its busy and dynamic shopping area and one of the primary shopping districts in Seoul. Many brand name clothing shops and department stores line up the streets and alleys. Transfer to the hotel or continue to enjoy Seoul nightlife on own. (B)

Day 6: March 15, 2019 – Departure. Transfer to Yongin airport for your flight to Japan to join your regular tour.



4 DAY – 3 NIGHT POST EXTENTION TO HIROSHIMA – NAOSHIMA

Day 9: March 22, 2019 – Departure: Breakfast at the hotel. First you will board a bullet train for Hiroshima from Kyoto where you will arrive in a little under two hours. Once you arrive your first stop will be to see the Atom Bomb Dome and Peace Memorial Museum. The dome, one of the only buildings to survive the blast, and museum keep alive the history of the world's first atomic bombing and speak not only to the past of the city, but to the hope that it has come to embody for a world without atomic weapons. Afterwards you will continue on to Hiroshima—and arguably one of Japan's--most beautiful temples: Itsukushima Shrine. The shrine, located on Miyajima Island, is best known for its torii shrine, which stands in the shallows of the beach and appears to float in the water at high tide. After you have walked across the causeways of the shrine you will return to Hiroshima for an overnight at your hotel. (B)

Day 10: March 23, 2019 – Kurachi – Naoshima Island. After breakfast you will start for your tour of Kurashiki area and Naoshima island; a picturesque district of canals and willows that brings to mind a traditional Japan of years gone. We will take another ferry to Naoshima, one of Japan's most ambitious art museums. Covering an entire island, Naoshima is a modern art fanatic's paradise as it includes outdoor installations and museums that curate exhibitions by some of Japan's greatest artists. Some highlights include: the chichu art museum, the benesse art museum, the Tadao Ando museum and a number of outdoor exhibitions. Before it gets too late, you will return to the mainland on the ferry and transfer to your hotel for the evening in Okayama city. (B)

Day 11: March 24, 2019 – Kansai – Higashi-Nada. On the last full day of your post tour you will complete the trip back to the Kansai area. After breakfast you will make your first stop at Himeji Castle, Japan's most lauded castle with its huge white walls and massive imposing structure. As you pass into Kobe you will make your first stop at the city's Chinatown, Nanking Town, with its bright and lively string of shops and restaurants. Your penultimate stop, on the way between Kobe and Osaka is the historic Higashi-Nada district, which is known as one of Kobe's main sake brewing districts and houses a number of domestically and internationally famous breweries. You will make a stop at the Hakutsuru sake museum where you can see exhibits on how sake is made, and maybe even purchase a bottle of one of Japan's most prodigious sake breweries. Finally, arrive at your hotel for your last evening and overnight in Osaka. (B)

Day 12: March 24, 2019 – Departure. Transfer to Tokyo and the airport for your flight back to the USA and say sayonara to Japan.
