July 6, 2022 - Dr. Jeff Weinland, CHA, CHE, CHAE, CHIA, former HFTP mid-Florida Chapter President passed away in his sleep on July 6, 2022. Jeff was an Assistant Professor since 2018 and a Lecturer from 2005 at the UCF Rosen College of Hospitality Management. In addition, Jeff was the President of the Board of the Vacation Villas at FantasyWorld for the past 18 years and created leading amenities that are now standard at many resorts. Jeff even introduced the Resort Mascot "Bear" two years ago to the FantasyWorld Resort.

Many of you will also remember Jeff, as a twenty plus year veteran of Bacchus Bash. Each year, Jeff would volunteer his time to support hospitality student scholarships by counting the cash. Jeff made a big difference to so many individuals within our industry and would try and help everyone he came into contact with.

Our heartfelt condolences go out to his family, the team at the FantasyWorld Resort, and the students and staff at UCF Rosen College of Hospitality Management.


Later, I was lucky to join with Jeff in the hospitality industry using his company Night Auditors of America to staff and complete my night audit function.
