



## STAR (STudent After-School Recreation) 2019-20

SHERWOOD CHRISTIAN ACADEMY

STAR is offered to SCA students in grades PreK-6.

STAR is provided on days that school is in session.

Hours: After-school until 6:00 PM

STAR enrollment requires a \$50 per child non-refundable Registration Fee and a monthly charge for the number of school days in the month (based on \$11/day for first child; \$10/day each additional child).

- We do not charge based on the number of days attended. You will be charged the monthly rate as long as your child is registered for STAR.
- STAR payments must be kept current in order to reserve your child's place in STAR. If payments are not kept current, SCA reserves the right to remove your child from the STAR roll if space is limited and another child is on the STAR waiting list.
- Children must be picked up by 6:00 PM. Late pickups will be charged \$5 for each 15 minutes past 6:00 PM, rounded up. (i.e. 5 min-\$5 charge, 20 minutes- \$10 charge, etc.)
- The STAR program does not accept drop-ins.
- Holidays: There is NO STAR provided on school holidays, therefore, the fees for those weeks will be reduced accordingly.

In the event of an emergency and the parents or guardians cannot be reached immediately, I give SCA STAR permission to secure such medical attention and care for my child as they deem necessary. I shall assume responsibility for payment of medical services. **NOTE: Contact and medical information will be taken from the information you provided in the Household, Medical Information, and Emergency Contacts & Authorized Pickup sections of the online enrollment packet. Please be sure keep this information up-to-date in FACTS Family Online (formerly RenWeb ParentsWeb).**

1. I agree to pick up my child each day by 6:00 PM and understand that I will be charged \$5 for each 15 minutes past 6:00 PM, rounded up. (i.e. 5 min-\$5 charge, 20 minutes- \$10 charge, etc.)
2. No medication will be given during the STAR program hours.
3. My child will not be permitted to enter or leave the facility without being escorted by a parent, authorized person, or program personnel.
4. I acknowledge it is my responsibility to keep my child's records current to reflect any significant changes as they occur, e.g., telephone numbers, work location, emergency contacts, child's physician, and child's health status, etc.
5. The staff agrees to keep me informed of any incidents, including illnesses, injuries, adverse reaction to medicine, which involve my child.
6. My child will participate in an afternoon snack.
7. I agree to abide by the Policies and Procedures for the STAR Program.
8. I acknowledge the Bright from the Start Exemption Notice below.

### K3, K4 & STAR Exemption Notice – Effective January 12, 2016

The K3, K4, and STAR (After School Program) are not licensed by Bright from the Start: Georgia Department of Early Care and Learning and are not required to be licensed.
