## Emergency Notification System

The Richardson Emergency Notification System allows for rapid notification via calls, texts, and emails. Examples of when the system may be activated include:

- Missing child
- Chemical spill
- Gas leak
- Evacuation
- Public health concerns
- Utility/water issues and outages

If you receive a call from the system which is NOT a test, listen to the entire message and follow the instructions provided.

*NOTICE: This system IS NOT utilized for severe weather due to lack of warning time. For immediate severe weather warnings, secure a NOAA All-Hazards Radio with Specific Area Message encoding (SAME) technology.*

### Don't be left in the dark. Stay Informed.

- Talk to your family about emergencies including where you would meet and how you will communicate:
  - Use social media, texts, and an out-of-state contact you would all call if local systems are impacted. Leave local connections open for 911 calls.
- Multiple sources of information are important in an emergency. Due to the sheer nature of emergencies, no agency can guarantee you will personally receive a notification for every incident. Keep yourself informed by monitoring all available warning and information systems:
  - Purchase a NOAA All-Hazards Weather Radio online or from your local hardware/camping store to receive audible alerts from the National Weather Service via a radio signal.
  - Download smartphone applications such as Weather Bug and the FEMA app for iPhone and Android.
