- Motion 11: Move that SI Chico donate \$1550 to the Chico History Museum to cover admission fees for 2nd and 3rd grade students in the Chico Unified School District. Schools designated Title 1 have high poverty rates and cannot afford the \$50 per class cost for the field trip.
- Motion 12: Move that SI Chico donate \$500 to the Chico Science Fair for its 2020 Science Fair To cover expenses for the Fair, which costs approximately \$14,000 and reaches over 1000 K-12 students in the Chico Unified School District.

- Motion 13: Move that SI Chico donate \$500 to SI Chico's Dress A Girl to purchase fabric and supplies, and cover other expenses needed to fabricate sundresses for girls in a country with significant human trafficking or natural disaster.
- Motion 14: Move that SI Chico donate \$1200 to Fair View High School to fund a weekly yoga class for young women who have been identified by counselors, psychologists, and teachers as at-risk. The 35 classes of 10-14 girls runs for the academic year and cost about \$3 per student per class.
- <u>Motion 15:</u> Move that SI Chico donate \$1100 from the Camp Fire fund to a student who experienced the Camp Fire to participate in the AAUW Tech Trek camp focused on developing interest and skills in science and math.
