Farmer is an industry professional with over 20 years of airport leadership experience and during her career has developed and led a wide variety of operational initiatives that support the mission and vision of the airports she serves. Lexie has a master's degree in public administration from Georgia State University as well as a bachelor's degree in aviation management from Embry-Riddle Aeronautical University. Farmer is also a Certified Member (C.M.) of American Association of Airports Executives (A.A.A.E.), an Airport Certified Employee (A.C.E.), and an Airport Security Coordinator (A.S.C). Regarding her new appointment, Farmer stated, "I am so excited to join the Greater Asheville Regional Airport Authority, and to be a part of the team that is working so hard to meet the demands of today while continuing to build for tomorrow. Asheville is growing, and I am eager to be part of planning for the airport of the future."
