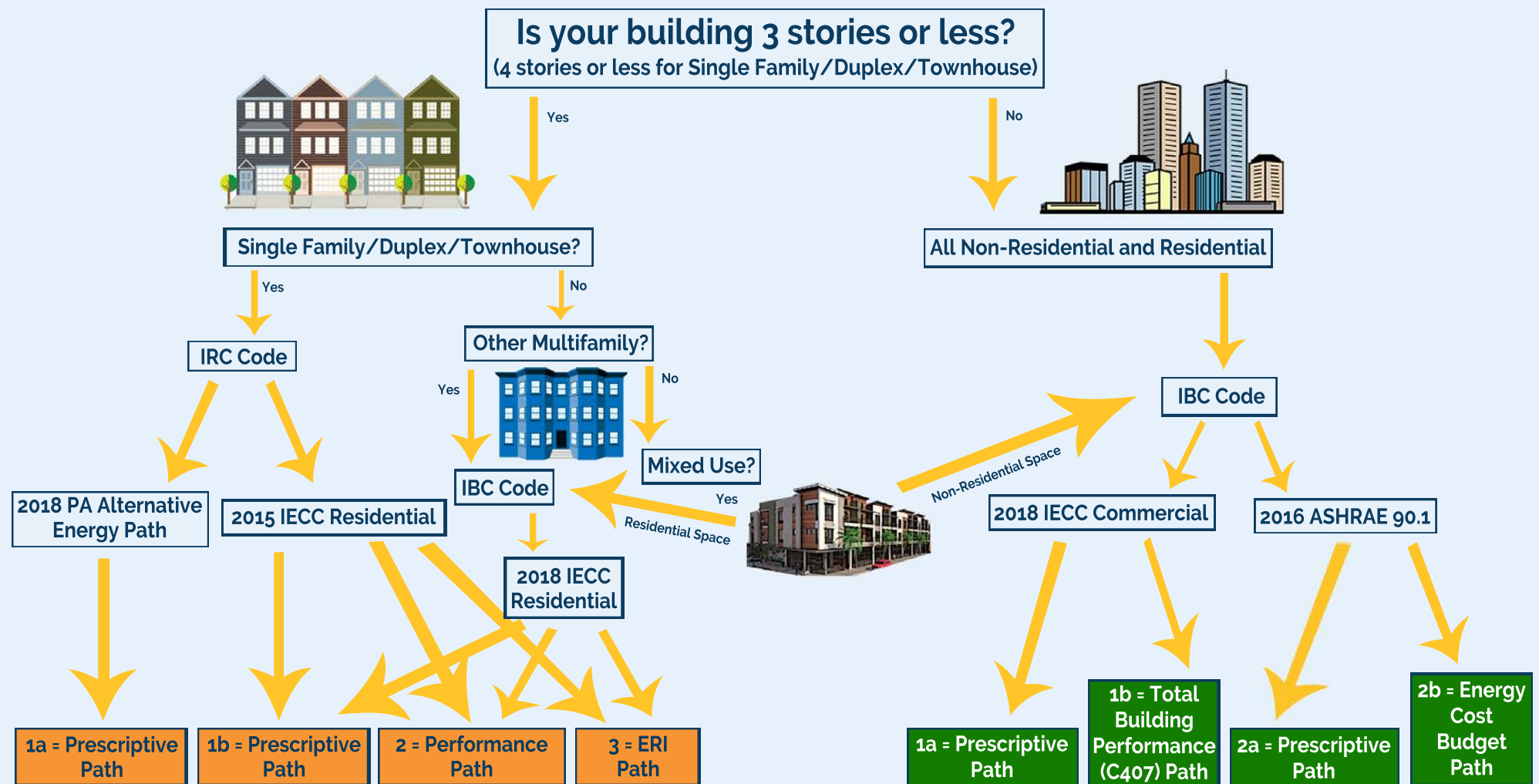

TESTING:	Optional Air Infiltration Test (C402.5) to Meet Target of 0.40 CFM/sq ft of Building Thermal Envelope.			
DELIVERABLE:	Signed Test Results, Optional Preliminary and Final Cx Reports or Field Verification Reports
