**Items may be loaded curbside at your appointment time by Treasured Estates staff by *advance request*.** You are responsible for bringing the proper packing materials and transportation.

Selected items may be delivered curbside to your address in Santa Barbara County for a fee. Selected items purchased by seniors, ages 65 or over, may be delivered at no cost, during this time of COVID-19 sheltering. Please use the [CUSTOMER SUPPORT button](#) to inquire *in advance* about these delivery options.

Items may be shipped by the Solvang UPS Store, 805-688-7116. Please contact the UPS Store directly for a quote, to arrange pick-up, payment, and insurance, if desired. Treasured Estates will not be responsible for any shipping costs, damage, or loss to any shipped items.

There will be a 7.75% Sales Tax applied to all items unless a current California State Resellers Permit is submitted.

**SAFETY Guidelines during COVID-19:** Six feet of social distancing will be maintained during pickup or delivery. If you have requested help loading an item into your vehicle, staff will do it for you while you wait at a safe distance, and pre-arranged deliveries are curbside, not inside your address. Clients are advised to use all recommended precautions regarding facial covering while away from home, gloves if desired, and so forth.
