For Inspiration and Recognition of Science and Technology (*FIRST*) (the "**Sponsor**") is offering a Sweepstakes that begins at 12:00:00 a.m. United States eastern standard time ("**LT**") in the Territory (defined below) on October 5, 2016, and ends at 11:59:59 p.m. LT in the Territory on November 6, 2016 (the "**Sweepstakes Period**") and includes five (5) winners, one selected by a random drawing from all eligible entries (except previous winners) on each of October 10, 2016, October 17, 2016, October 24, 2016, October 31, 2016, and November 7, 2016 (see Rule 4, below), each to win a Printrbot prize package (described in Rule 6, below). A *FIRST* Tech Challenge Team based in one of the fifty (50) United States or District of Columbia is automatically entered into the Sweepstakes when the team pays its *FIRST* Tech Challenge registration during or before the Sweepstakes Period. Other eligible persons may enter by completing and submitting an entry form (as described in Rule 3.b, below) during the Sweepstakes Period. There is a limit of one entry per Participant. Void where prohibited. The Sweepstakes is governed by these Official Rules.

The database clock for the servers at Sponsor will be the official timekeeping device for the Sweepstakes. Except as otherwise specifically stated in these Official Rules, all times mentioned in these Official Rules are United States eastern standard time ("**LT**"). A day is the 24-hour period beginning at 12:00:00 a.m. LT and ending that same day the following 11:59:59 p.m. LT (a "**Day**").

2. WHO IS ELIGIBLE TO ENTER/WIN. The Sweepstakes is open only to *FIRST* TECH CHALLENGE Teams based in the fifty (50) United States or District of Columbia (the "**Territory**") and individuals who are residents of the Territory and who are eighteen (18) years of age or older on the day of participation (each a "**Participant**"). (Any eligible Participant who is eighteen or older, but younger than the age of majority in his or her jurisdiction of residence, is referred to in these Official Rules as a "**Minor**".) Persons in any of the following categories are NOT eligible to participate in the Sweepstakes: any person who on or after June 1, 2016, was or is (a) an officer, employee, agent or independent contractor of Sponsor; or (b) an immediate family member (defined as spouse, IRS dependent, or biological, foster, in-law, adoptive or step- mother, father, sister, brother, daughter or son) of, or anyone who resides in the same household as, an officer, employee, agent or independent contractor of Sponsor. Each Participant, and their parent or legal guardian if the Participant is an eligible Minor, unconditionally accepts and agrees to comply with and abide by these Official Rules.

3. HOW TO ENTER THE SWEEPSTAKES. There are two ways to enter the Sweepstakes:

A. *FIRST* Tech Challenge Teams. A *FIRST* Tech Challenge Team based in the Territory is automatically entered into the Sweepstakes when the team pays its *FIRST* Tech Challenge registration during or before the Sweepstakes Period. Prize will be issued to "Coach 1" as listed in the team registration data

for use at their discretion.

B. Enter Without Registering an *FIRST* Tech Challenge Team: Other eligible individuals may enter by completing the online entry form at <http://info.firstinspires.org/3dprinter> during the Sweepstakes Period.

C. Limits: There is a limit of one (1) Entry (with or without purchase) per Participant, and a limit of one (1) prize per Participant throughout the entire Sweepstakes Period.

4. DRAWINGS/ODDS OF WINNING. One (1) potential winner (subject to verification) will be selected in each of five random drawings, conducted by an employee of Sponsor on the Drawing Dates stated below, from all eligible entries as of the entry close date and time stated below. 5. WINNER NOTIFICATION. Sponsor's redemption center (the "**Redemption Center**") will contact each potential winner by email within approximately two (2) business Days after the applicable drawing. The potential winner will be required to respond to the instructions in the email sent by the Redemption Center within three (3) business days and to provide the Redemption Center with complete contact information (including but not limited to daytime telephone number and complete mailing address) that the Redemption Center will use to send the potential winner prize claim documents ("**Prize Claim Documents**"). The Prize Claim Documents will include an affidavit of eligibility/release of liability and publicity release (where permitted by law), an IRS Form W-9, and any other documentation reasonably requested by Sponsor, all of which a potential winner must complete and return within five (5) business Days of the date the Prize Claim Documents are sent to the potential winner. The total ARV of all prizes available in this Sweepstakes is \$2,260.

7. PRIZE CONDITIONS/RESTRICTIONS. All details and other restrictions not set forth in these Official Rules will be determined by Sponsor in its sole discretion. If Sponsor so elects, a potential prize winner may be required to submit to, and cooperate in, a confidential background check to confirm eligibility and security requirements set by the Sponsor to help ensure that the use of any such person in advertising or publicity for the Sweepstakes will not bring Sponsor into public disrepute, contempt, scandal or ridicule or reflect unfavorably on the Sweepstakes or the Sponsor as determined by Sponsor in its sole discretion. An IRS Form 1099 may be issued. Accordingly, a potential winner will be required to submit their social security number as a condition of receiving the prize. Participants assume all risk of loss, damage, destruction, delay and misdirection of Prize Claim Documents and are advised to obtain insurance where appropriate. SOME STATES DO NOT ALLOW THE EXCLUSION OF IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION MAY NOT APPLY.

11. MISCELLANEOUS.

A. Disqualification: It is the Participant's sole responsibility to ensure that they have complied in full with all conditions and requirements contained in these Official Rules. No mechanically reproduced, illegible, incomplete, forged, software-generated, third party or other automated or robotic entries, in whole or in part, will be accepted or valid. Entries made by any individual or any entity other than the Participant and/or originating by any other mechanism, including but not limited to commercial sweepstakes subscription notification and/or entering services, will be declared invalid and disqualified from this Sweepstakes. Sponsor reserves the right in its sole discretion to disqualify any individual who is

found to be tampering with the Entry process or the operation of the Sweepstakes; to be acting in violation of these Official Rules; or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Sweepstakes, or to annoy, abuse, threaten or harass any other person. The Sponsor reserves the right to seek damages and other remedies (including attorneys' fees) from any such person to the fullest extent permitted by law.

B. Force Majeure/Printing and Production Errors: Sponsor reserves the right, without prior notice and at any time, to terminate the Sweepstakes, in whole or in part, or modify, suspend or extend the Sweepstakes or Sweepstakes materials in any way, if it determines, in its sole discretion, that any Sweepstakes materials and/or Prize Claim Documents reflect printing, production or other errors, or if it determines, in its sole discretion, that the Sweepstakes is impaired or corrupted or that fraud or technical problems, failures, malfunctions or errors (including, without limitation, viruses or other deleterious programs or materials, glitches or printing or production errors) have destroyed or severely undermined the proper entry, integrity and/or feasibility of the Sweepstakes. In the event Sponsor is prevented from continuing with the Sweepstakes as contemplated herein by any event beyond its control, including but not limited to fire, flood, natural or man-made health epidemic, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal, state or local government law, order or regulation, public health crisis, order of any court or jurisdiction or other cause not reasonably within Sponsor's control, then subject to any governmental approval which may be required, Sponsor shall have the right to modify, suspend, extend or terminate the Sweepstakes. Only the type and quantity of prizes described in these Official Rules will be awarded.

C. Invalidity: The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Headings and captions are used in these Official Rules solely for ease of reference, and shall not be deemed to affect in any manner the meaning or intent of these Official Rules or any provision hereof. These Official Rules cannot be modified or amended in any way except in writing by a duly authorized representative of Sponsor.

D. Governing Law: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations as between Participant and the Sweepstakes Entities in connection with the Sweepstakes shall be governed by and construed in accordance with the internal laws of the State of New Hampshire including procedural provisions without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's or jurisdiction's laws.

E. Privacy: Except as otherwise contemplated in these Official Rules, Participants' contact information collected by Sponsor in connection with the Sweepstakes will be used by Sponsor in accordance with the *FIRST*'s Privacy Policy found on firstinspires.org (the Privacy Policy can be found at <http://firstinspires.org/about/privacy-policy>).

12. ARBITRATION. By participating in this Sweepstakes, each Participant agrees that: (1) any claim, dispute or controversy (whether in contract, tort or otherwise) Participant may have against any of the Sweepstakes Entities arising out of, relating to or connected in any way with the Sweepstakes, the awarding or redemption of Prizes, or the determination of the scope or applicability of this agreement

to arbitrate, will be resolved exclusively by final and binding arbitration administered by JAMS and conducted before a sole arbitrator pursuant to JAMS's Comprehensive Arbitration Rules and Procedures ("Rules and Procedures"); (2) this arbitration agreement is made pursuant to a transaction involving interstate commerce, and shall be governed by the Federal Arbitration Act ("FAA"), 9 U.S.C. §§ 1-16; (3) the arbitration shall be held at Manchester, NH or at such other location as may be mutually agreed to by the Participant and Sponsor; (4) the arbitrator's decision shall be controlled by the terms and conditions of these Official Rules and any of the other agreements referenced herein that the Participant may have entered into in connection with the Sweepstakes; (5) the arbitrator shall apply New Hampshire law consistent with the FAA and applicable statutes of limitations, and shall honor claims of privilege recognized at law; (6) there shall be no authority for any claims to be arbitrated on a class or representative basis as Participant and Sponsor hereby waive the right to assert claims in any class or representative action; arbitration can thus decide only the Participant's and/or Sponsor's individual claims; the arbitrator may not consolidate or join the claims of other persons or parties who may be similarly situated. If any part of this arbitration provision is deemed to be invalid, unenforceable or illegal, or otherwise conflicts with the Rules and Procedures established by JAMS, other than subpart (6), then the balance of this arbitration provision shall remain in effect and shall be construed in accordance with its terms as if the invalid, unenforceable, illegal or conflicting provision were not contained herein. If, however, subpart (6) is found to be invalid, unenforceable or illegal, then the entirety of this Arbitration Provision shall be null and void, and neither Sponsor nor Participant shall be entitled to arbitrate their dispute. Finally, this arbitration provision is reciprocally binding all parties, such that both Participant and Sponsor are required to arbitrate their claims against one another.
