September 27-28, 2018 **Cash Flow Analysis II: Applied Concepts (2 day class)**

RMA's *Cash Flow Analysis II: Applied Concepts* teaches you to link financial analysis to industry, business, and management risk issues and enables you to effectively negotiate a lending request. This course is primarily for experienced lenders who are already proficient in financial accounting, financial statement analysis, and cash flow analysis. Credit trainees and other support personnel may benefit if they have the requisite skills.

October 11, 2018 **Problem Real Estate Loans**

This course is aimed at real estate lenders who may encounter problem loans in their portfolios. It focuses on the underlying business drivers for commercial real estate, the reasons for problem loans in real estate, and common factors leading to problem loans. It provides participants with an analytical framework and outlines various options for dealing with problem real estate credits, including the advantages and disadvantages of workouts, various workout strategies, and deed-in-lieu and foreclosure considerations.

November 7, 2018 **Commercial Real Estate Lending Two: Underwriting**

Commercial Real Estate Lending II: Underwriting provides a best-practices approach to quantifying cash flows of various styles of Commercial Real Estate (CRE) property for underwriting. Topics include 1) the analytics necessary for a unified analysis for loan consideration, including measuring cash flow for debt service and assessing quality of its sources, 2) the lease review process 3) alternative methods to reach a valuation, 4) testing loan performance under adverse conditions, and 5) creating a loan structure that helps preserve cash flow.

January 14, 2019**Advanced Loan Documentation and Structuring**

This class is based on “What, Why, and When”, and how to select documentation, secure collateral and structure loans to achieve your credit risk management goals.

The Advanced Course will:

- address specialized areas of lending and associated documentation and structure
- expand your knowledge of credit structure tools that will reduce your credit risk exposure
- increase your ability to discuss and present various documentation/structure options to lenders and borrowers.

February 25, 2019**Essentials of Credit Presentations**

The objective of this course is to provide informative, practical information related to the creation of more effective written loan presentations. This is the cap stone course for the Advanced Credit Analyst Series. Loan presentations that lack focus, ignore crucial factors or that are incomplete, leave a negative impression about your credit risk administration in general. Once that impression is created, it can be difficult to change. This is particularly important in a regulatory environment where examiners are highly focused on the lender credit risk process. Includes examples and recommendations.
