




CARDBOARD BOAT RACE RULES

Saturday, July 3rd at 1:00pm


RULES FOR ALL TEAMS

1. Teams consist of 4 people. Two people in the crew will start at one end of the lap pool and race to the other end where the remaining 2 teammates will be waiting. The 2 teammates in the boat will switch with the 2 teammates waiting on the pool deck upon reaching the other side of the pool
 2. The boat will then be raced back to the original starting point for the end of the race.
 3. The race must begin and end with the two-person crew intact. Any use of lane lines, sides of the pool for pushing or pulling your boat will result in a disqualification.
 4. All participants' arms and legs must be in the boat at all times. Body parts may not be used to propel the boats. Pool noodles can be used as oars at your own expense. A maximum of two pool noodles can be used as oars.

CARDBOARD BOAT RACE RULES

Rules and Supplies for Boats

1. Any Valley Ranch resident or Little Valley Rancher can participate with the maximum of two adults per team (age of 18 or older).
 2. The entire hull, superstructure, and seating of all boats must be made entirely of cardboard.
 3. Teams can use duct tape for seams and joints. The whole boat **CANNOT** be covered in tape. No chemicals can be used on the boat that can bleed into the pool.
 4. Your boat must be free of sharp edges, pointy objects or anything else that could cause injuries.
 5. The boat's passenger area must not be permanently enclosed.

5. Absolutely NO use of the following items: Tar-based substances, two-part varnishes, fiberglass resin, epoxy glue, any other two-part substances, or corrugated cardboard that's bonded to any material. Only Duct tape, and cardboard. Colored or decorative duct tape is permitted. Theming and costumes is allowed and must not contain any of the above items.
6. To qualify as a finisher in any heat, you must be IN your boat, not towing it in your teeth or between your legs and you must exit the boat with both feet touching the pool deck.
7. Heats will consist of no more than 4 boats at a time. All times will be taken for each team and the top times will be named 1st, 2nd, and 3rd place

I agree that this release shall be legally binding upon me personally, all members of my family, including minors performing with me, my and their heirs, successors, assigns and legal representatives, it being my intention to fully assume all the risk of performance and to release the Valley Ranch Community Owners Association from any and all liabilities to the maximum extent permitted by the law.

I understand that Valley Ranch Community Owners Association reserves the right to take photographic or film records of any of its events and hereby agree that the Valley Ranch Community Owners Association may use any such photographic or film records for promotional and/or commercial purposes.
