## **CONTINUING EDUCATION SEMINAR – Bell & Spina**

### **“Building Enclosure Commissioning (BECx)”**

Although referenced in codes, regulatory standards and Owner’s programmatic requirements, the applied aspects, goals and benefits of building enclosure commissioning are sometimes unknown, if not misunderstood. This presentation will outline the intent of BECx and its process from project inception through occupancy. Case studies of past BECx projects will be presented.

- Understand the purpose and goals of Building Enclosure Commissioning (BECx).
- Be familiar with related standards and the agencies responsible for their evolution.
- Realize that BECx is a team effort including the Owner’s Representatives, Designers, Contractors, and the Commissioning Agent.
- Be familiar with the administration, design, construction, and post-occupancy processes of BECx.



**Neil W. Garry** is a partner at the Rochester, New York office of Bell & Spina, Architects-Planners. Much of his 23-year professional career has focused on the technical aspects of building envelope systems. He is a licensed Structural Engineer (PE), Building Enclosure Commissioning Process Provider (BECxP), Commissioning Authority + Building Enclosure (CxA+BE), IIBEC Registered Roof Consultant (RRC), Registered Exterior Wall Consultant (REWC) and Thermal / Infrared Thermography – Buildings & Roofs Specific. Neil is a member of ASTM International Technical Committee DO8, Roofing and Waterproofing, and Committee E06, Performance of Buildings.

**Chapter 11: Construction Requirements for Existing Buildings** – This course will provide some awareness to the minimum construction requirements for existing buildings. Fire Code of New York State - Chapter 11: Construction Requirements for Existing Buildings brings together many of the retroactive existing building, fire protection and life safety requirements previously found in Chapters 7, 9 and 10 to one location for a more convenient and user-friendly enforcement tool.

- The student will be able to identify and apply fire safety requirements for existing buildings using Chapter 11 of the 2020 Fire Code of New York State.
- Upon completion of the course the attendee shall be able apply occupancy specific provisions towards means of egress components, existing elevators or stairways and fire protection systems, such as automatic fire sprinklers and smoke and fire detection systems.
- Understand where the provisions of this chapter conflict with the building code that applied at the time of construction, the most restrictive provision shall apply.
- Evaluate how in the absence of any evidence of compliance with a building code at the time the building was constructed, how to apply Chapter 11 with the 2020 Existing Building Code of New York State to achieve compliance.

**Alternate Fuels – Use, Storage, Handling & Vehicle Fire Safety** - This course reviews the fire safety requirements for alternate fuel vehicles with respect to use, storage and handling fueling of alternate fuel vehicles.

- Through a brief overview, this presentation will familiarize first responders with the various alternative fuel technologies.
- Additionally, this presentation will provide code related resources, guidance with educational materials in the storage, handling and dispensing of alternative fuels.
- Provide awareness for first responders as to dangers with alternate fuels and how it affects fire suppression activities, resources, and training.
- Taking a closer look at recent fires and incidents throughout the United State and discuss the lessons learned from these events and how to use and or handle this technology safely in the public.



**Christopher Roth** is the Chief Fire Marshal for the Town of Brighton in Monroe County. He has 26 years of experience as a Chief Fire Marshal and Commercial Building Inspector. He also has over 20 years of fire service experience, achieving the highest rank of Chief of his department. Christopher is past president of the New York State Fire Marshals and Inspectors Association and has served various roles in Monroe County Fire Marshals and Inspectors Association. In addition, he holds an associate degree in Fire Protection Technology from Corning Community College and is an adjunct instructor with Monroe Community College and New York State Department of Homeland Security and Emergency Services. He currently chairs the National Fire Protection Association 96.
