

Endorsement Renewal Requirement Tracker

As of December 15, 2024, the renewal process has shifted to a three-year cycle with an attestation process. Attestation means you agree that you have evidence of meeting all the requirements for renewal. You would only need to provide that evidence if you are audited. This form serves as a practical and convenient tool for members to document their progress toward renewal benchmarks, ensuring you remain on track. Additionally, maintaining an updated record using this form provides a ready reference in the event of a spontaneous audit. It's important to note that this worksheet is for members' personal use only and does not need to be submitted to CT-AIMH.

Members will have the entire 3-year period to complete training hours and Reflective Supervision/Consultation (RS/C) hours. The next renewal attestation date is **October 1, 2027, to December 15, 2027**.



Tips: Save this worksheet in a folder, along with your training certificates, on your computer for easy access later. Update the form every couple of months and review the form annually to track your progress.
