2020 COVID-19 Pandemic

EARLY TIMELINE:

- March 6-First COVID-19 cases reported in CT
- March 15-CT governor cancels classes at all public schools until April 20 (on 4/10/20-extended to May 20)
- March 16-CT governor limits gathering sizes to under 50, and places limits on bars and restaurants to off-site only and closed gyms, movie theaters, etc.
- March 16-Pres. Trump announced –"15 days to slow the spread"
- March 17-20 -worked with training coordinator and venues to postpone and reschedule spring conf, both Spanish evening series and 8-day series
- March 18-Pres. Trump signed Families First Coronavirus Response Act
- March 20-CT governor declares-"Stay Safe Stay Home" and all non-essential businesses asked to close and offer work from home options if possible

- March 20- CT-AIMH sent out letter of hope with COCVID-19 resources from ED and CT-AIMH BOD
- March 24-25-ED connects with grant funders about adjustments to implementation of projects and potential for virtual events
- March 26-Secured a PO Box in Noank for checksas Yale is closed
- March 27-Pres Trump signed the Coronavirus Aid Relief and Economic Security Act (CARES)
- March 27- Webinar with Rep. Rosa DeLauro about CARES Act and loans available
- March 29-Pres Trump approved major disaster declarations from CT



Policy and Advocacy:

Goal Statement: Work to identify, monitor and respond to policy and health issues related to the mental health needs of, young children and their families. Establish relationships with community partners, which may include the Connecticut Chapter of the American Academy of Pediatrics, State Legislators, Child Advocate, and other State Leaders. Monitor and advocate for ongoing funding for services for infants, young children and their families, and promote strong policies for infants, children and their families. For example: Earned Family Leave and Medicaid Reimbursement for IMH services, and other relevant issues.

Continue to offer, support, or sponsor high-quality conferences, training series, presentations and forums. Partner with other training providers to integrate competencies into their current trainings. Ensure that higher education curricula and other curricula are cross walked with the competencies.

2020-2021 News:

- Conversation with CAFAF about delivering Foster Parent training series

- Purchased IMH Endorsement in Spanish with funding from CHDI

- Sent 2 bi-lingual presenters to a Reflective Supervision training in Boston
- CT-AIMH Membership database merged and then revised



2020-2021 Endorsement® News:

- As of September 2021, there are 100 Infant Mental Health Endorsees (IMH-E®) and 12 Early Childhood Mental Health Endorsees (ECMH-E®).
- Over 100 Endorsed by the end of 2021!
- Spanish Infant Mental Health
 Endorsement® became available in 2021
- First person was Endorsed using Spanish version of the Endorsement in 2021.

Membership



- Infants and young children and their caregivers deserve support and services that encourage nurturing relationships. By joining CT-AIMH- together we can move forward in creating an infant/early childhood mental health system in Connecticut.

Audience-Specific Trainings



All trainings offered through the CT Association for Infant Mental Health (CT-AIMH) are related to the competency requirements, that when met lead to an Endorsement in Culturally Competent, Relationship-Focused Practice Promoting Infant Mental Health®.

Every series is tailored to the audience and the presenters are instructed to make their examples, case studies, and handouts relevant to the target audience.

Whenever possible, food is served and attention to participant needs is a high priority in order to create an environment that is centered around relationship-building.

To promote access, Endorsement and Membership Fees have been included in training series contracts to cover those costs.

Reflective Supervision/Consultation groups may be offered in conjunction with some training series.

Audience-Specific Trainings



Child Care Audience

- 4-6 partial day or evening sessions focused on working with groups of infants and toddlers. Sessions are tailored to each community and often include additional evening sessions for family home childcare providers. Series was offered in Spanish 3 times. Offered virtually.
- 147 trained in 2020-21
- 369 trained YTD

Child Welfare and Head Start Audience & Home Visitors

- 8 topics of training focused on unresolved trauma, loss and grief. Virtual in 2020-21
- 207 trained in 2020-21
- 956 trained YTD

Clinician Audience

- 18-month training in Trauma-Informed Child Parent Psychotherapy (CPP), 7 or 8 in-person full days, and 18 months of consultation calls (2 calls/1 hour each/month).
- 0 trained in 2020-21
- 27 trained YTD

CT-AIMH Seminars, Workshops, Trainings and Conferences

- Offered at least twice a year to <u>all</u>
 <u>professionals/disciplines</u> working with infants and
 toddlers and their families. Offered Virtually.
- 307 trained in 2020-21 (Fall 2020, Spring 2021)
- 3,098 trained YTD

Audience-Specific Trainings



<u>Higher Ed - Faculty Audience</u>

- 2-day symposium titled: The Faculty Symposium on Embedding Infant and Early Childhood Mental Health Principles into Curricula created in Minn. 3 presenters from Minn. presented 4 topics of the 10 created with 2 in-state keynote presenters that spoke to 2 of the 4 topics.
- 0 trained in 2020-21
- 24 trained YTD

Home Visitor Audience


- 6 -day series focused on the unique aspects of home visiting and promoting the attachment relationship between a caregiver and their infant or young child.
- 0 trained in 2020-21
- 127 trained YTD

<u>Pediatrician Audience</u>

- 4- minute presentation during lunch hour (lunch provided) focused on Infant Mental Health (developed in partnership with CHDI, and now can be accessed through CHDI
- 0 trained in 2020-21
- 14 offices trained YTD

Reflective Supervision for Supervisors

- Began as a 5-day training series, with both in-state and out-of-state presenters. It also had a 2-day follow-up and ½ day follow-up. There was a focus on embedding the newly developed RIOS. The series was then trimmed to 4.5 days.
- 30 trained in 2020-21 (only held 2020)
- 126 trained YTD

Reflective Supervision



As in relationship-focused practice with families, reflective supervision/consultation (RS/C) is most effective when it occurs in the context of a relationship that has an opportunity to develop by meeting regularly with the same supervisor/consultant over a period of time.

- CT-AIMH values Reflective Supervision/ Consultation (RS/C) and promotes inclusion of RS/C within each grant.
- RS/C is currently being offered to staff across many agencies/disciplines, including: Birth23, Department of Children Families, Family Based Recovery, Higher Education Faculty, Office of Early Childhood Home Visitors, and more.

2020-2021 Reflective Supervision News:

- Offered 4.5- day RS/C Training Series in 2020.
- OEC provided funding for B23 and HV supervisors to attend 3 RS groups- 33 attended in 2020, 41 attended in 2021.
- 12 Higher Ed faculty attended RS in 2020-2021.
- For the first time, in 2021, we offered RS/C to childcare providers in English and Spanish.
- DCF funds 2 RS groups/year for multiple disciplines. 11 attended in 2020 and 5 attended in 2021.

Next Steps for CT-AIMH



- DCF will continue to fund 8-topic IMH training series and RS/C groups
- OEC will continue to fund RS/c groups for HV and B23 supervisors, existing IMH8-topic training series, a 4.5-day RS training series, as well as limited funds for Endorsement
- OEC will continue to fund the IMH childcare series in English and Spanish, Endorsement, and Reflective Supervision/Consultation
- Continue to roll out the Spanish version of EASY
- Create a line item in the OEC and/or DCF budget for CT-AIMH-sustainability
- Increased focus on DEIA efforts first through BOD and then DEIA Advisory Committee, then in all committees

- Partner with state agencies to offer an IMH and Behavioral Health Symposium
- Continue to support Medicaid Reimbursement
- Develop CT-AIMH 101 PPT
- BOD continue to support fundraising and sponsorships
- BOD finish the policy and staff handbook
