

## **MDEQ Recognizes 2020 *enHance* Members**

MDEQ recently recognized the new and renewing members of the *enHance* environmental stewardship program accepting three new members and twelve renewing members into the program for the 2020 class. *enHance* is a voluntary stewardship program that recognizes committed environmental leaders who initiate waste reduction and pollution prevention efforts that go above and beyond the standard environmental regulatory requirements. *enHance* is open to manufacturers and other industrial and commercial facilities, to local governments and to other entities who are interested in the program and who meet the eligibility requirements. Applicants are able to apply for membership at one of three tier levels: Leader, Steward, or Associate.

The annual recognition of *enHance* members is normally done in April each year at the workshop and awards luncheon jointly sponsored by MDEQ and the Mississippi Manufacturers Association. However, this year's workshop and awards luncheon was postponed and ultimately cancelled due to restrictions and conditions related to the COVID-19 pandemic. Consequently, MDEQ wants to recognize these new and renewing members who have continued to work to improve environmental conditions in their community despite the challenges of the ongoing pandemic.
