Inhalers

Spiriva Hospital-to-Home Program

- Ensures that patients receive uninterrupted therapy between being discharged from the hospital and 30 days after.
- Eligibility
 - Patients discharged from the hospital needing the medication in order to continue therapy
 - A free 30 day supply and educational and saving resources are delivered to the patient's home within 1 business day
 - Patients are eligible to participate in this program up to twice a year.
- How to Apply:
 - Patients can be enrolled by fax or online, but must be enrolled by a practicing physician.
 - Prescriptions for Spiriva can either be e-prescribed, faxed, or called in.
 - Both patient and physician will receive support calls within 48 hours after enrollment.

Incruse Savings (ELLIPTA)

- Two offers are available:
 - Free 30 day supply (with voucher)
 - Pay no more than \$10/month on Incruse for 12 months
- Who is eligible:
 - Patient must be 18 years of age or older
 - Patients who have primary insurance, but insurance may not cover the full cost of the prescription
 - Patients without insurance coverage
 - Eligible patients **without** insurance will receive up to \$100 off on each 30 day supply.
 - Any patient with government funded insurances or under government funded programs are **NOT** eligible to receive aid.

Breo Savings (GlaxoSmithKline)

- Two different offers:
 - First 30 day prescription is free
 - Patients with or without insurance are eligible to participate.
 - Pharmacy cannot submit to government funded insurance in addition to the free offer
 - Patients with government funded insurance programs are **NOT** eligible to receive aid.
 - Patients without insurance will receive up to \$100 off on each 30 day supply.
 - Pay no more than \$10/month for 12 months on a 30 day prescription

Patient Assistance Programs

Novo Nordisk Patient Assistance Programs (PAP)

- Provides a free 120 day supply of medication sent to the prescriber's office that can be picked up by the patient at his or her convenience.
- Eligibility
 - Patient must be a US citizen or a legal resident
 - Cannot have or qualify for any prescription coverage, Medicare, Medicaid, or Veterans' Affairs benefits
 - Patient's total income must be $\leq 300\%$ of the Federal Poverty Level
 - If the patient has applied for Medicare, they must have been denied for the Low Income Subsidy (LIS) program
 - If the patient is eligible for Medicaid, they must have been denied by the program

How to Apply for Novo Nordisk PAP

- Patient must print and fill out application found on the Novo Nordisk website
- Proof of income, copy of the previous year's federal tax return, 2 current paycheck stubs, a copy of W-2 or 1099 Form, and Medicare Part D coverage gap documentation (if applicable) should be included with the application.
- How to send in the application:
 - Patients can fax their documents to (866)-441-4190
 - Patients can also mail a hard copy of their documents and application to: Novo Nordisk Inc., PO Box 370, Somerville, NJ 08876
- Medical records are **not** to be included with the application

NovoMedLink

- Complimentary drug samples to licensed practitioners for appropriate patients.
- Sample requests can be found on the website online and faxed in after completion.
- Sample requests can be processed every 30 days.

NovoMedLink

- Who is eligible :
 - Patients get samples through provider
 - Patients must be on one of the supplied medications including:
 - Levemir (vial or FlexPen)
 - GlucaGen
 - Tresiba FlexTouch
 - Novolog (vial or FlexPen)
 - Novolog Mix 70/30 (vial or FlexPen)
 - Victoza
 - Vagifem
 - NovoFine Pen Needles

Sanofi Patient Assistance Program

- Who is eligible:
 - Patient must be a U.S. citizen or resident and be under the care of a licensed healthcare provider
 - Annual household income of $\leq 250\%$ of the current Federal Poverty Level
 - Patient is eligible for up to 12 months of assistance
 - Patients can re-apply on a yearly basis if longer assistance is required

How to apply for Sanofi:

- Download and print an application from their website (<http://www.sanofi.us>)
- If you do not have access to a computer, you may begin the application process by calling the program, toll free, at 1-888-VISITSPC (1-888-847-4877)
- Your healthcare provider may also submit applications through these methods or online through the provider portal.

Examples of Sanofi Insulin Products:

- ADLYXIN (lixisenatide injection 20 mcg)
- Apidra (insulin glulisine [rDNA origin] injection)
- Lantus (insulin glargine injection)
- SOLIQUA 100/33 (insulin glargine and lixisenatide injection) 100 Units/mL and 33 mcg/mL
- Toujeo (insulin glargine injection) U-300

Lilly Cares: Eli Lilly's Patient Assistance Program

- Patients can receive up to a 1 year's worth of medication in shipments of 120 day supplies.
- Eligibility
 - Permanent, legal resident of the United States
 - Not enrolled or eligible for Medicaid or VA benefits
 - If eligible for Medicare Part D, must be enrolled and have spent over \$1,100 on medication the past calendar year
 - Have to be prescribed a medication that is covered under Lilly Cares
 - Household is under the Annual Income Limit

Lilly Cares Household Income Guidelines

Household Income Guidelines:

- The total number of people in the household includes yourself and each of your dependents.
- Total yearly income includes incomes from all earners in your household.
- To qualify, your total yearly income cannot exceed the values listed below.

How to Apply for Lilly Cares

- Patients must download the application online or can request it by calling 1-800-545-6962
- Patient and prescriber must fill out the application and send completed application as well as proof of income
- Patients can receive an optional text alert after application has been approved

What Lilly Products Are Covered

Group A: For patients who are eligible for and have enrolled in Medicare Part D **OR** have no insurance.

Blink Health

Blink Health Program

- How does it work?
 - Patients go online through the app on their phone, and type in the name of their medication.
 - There are no membership fees or no monthly premiums
 - Patients pay for their prescriptions online and will receive a “Blink Card” to either print off or have on their phone via text or email
 - Valid date of birth must match on the Blink Card as well as the prescription.
 - Patients fill their prescriptions at a pharmacy like they normally would, but show the Blink Card for processing information for \$0 charge at the counter.
- Patients pay online via the website or the app and pick up prescriptions at a local pharmacy

Blink Health Program

- Medications are offered by Blink Health at discounted prices (some up to 90% off)
- Examples include:
 - Zocor (Generic) AWP: ~~30.52\$~~
Blink Health Price: 4.91\$ (84% off)
 - Prilosec (Generic) AWP: ~~173.12\$~~
Blink Health Price: 9.92\$ (94% off)
- Who is eligible?
 - Patients without insurance
 - When the Blink price is less than your commercial plan copay
 - Medicare patients
 - Patient doesn't have to be legal resident or citizen
 - No proof of income needed

Blink Health Program and Residency

- Patients would not have to be documented residents in order to receive discounts
- Only concern would be ability of patients to pay for medications without a debit/credit card.
 - Possible for patients to purchase Visa gift cards at a local store and pay for medications with the card.

How Does Blink Provide These Prices?

- Blink provides a network of over 25 million people
- Prices are researched and compared and the best price between pharmacies is chosen.
- Blink combines patients together to leverage purchasing power in order to assure that patients are receiving the lowest possible price.

40% Off Lilly Insulins with Blink

- Beginning in 2017, Blink has partnered with Eli Lilly to provide 40% off insulins.
 - Discounted prices will take effect January 1, 2017
 - Discounts will be honored at over 67,000 pharmacies nationwide.
- Main goal is to increase the availability and affordability of insulin
 - This increase in affordability can lead to increased patient adherence.

What Does the Blink/Lilly Program Include?

- Humalog® (insulin lispro injection 100 units/mL)
 - One of the most widely prescribed insulins
- Humulin® U100 formulations (insulin human injection 100 units/mL)
- Basaglar® (insulin glargine injection 100 units/mL)
