CURREN	IT SITUATION						
Crews are ready to respond to evolving situations as more rain is expected throughout the area. Crews are posted throughout the area, and continue to assist with flood mitigation efforts, welfare checks and water rescues. Scattered showers will continue this morning as snow falls in the mountains. The valley has received 0.25 inches of rainfall, with another 0.25 - 0.75 inches impacting the foothills. The mountains have received an inch of rain. Another 6 – 12 inches of snow is expected to fall above 4,000 feet. Shower and isolated thunderstorm activity will increase during the afternoon and evening hours. Weather is expected to be seasonably cool Thursday, with a few lingering showers.
