#### USDA Approves Florida's Request to Launch Online Grocery Purchase Pilot Program

The Florida Department of Children and Families (DCF) announced Florida will pilot a program for Supplemental Nutrition Assistance Program

(SNAP) recipients to purchase groceries online through **Walmart** and **Amazon** with the use of an EBT card.

This is an accommodation the statewide **Centers for Independent Living** (CILs) were able to advocate for through the designated "CIL Seat" – thanks to Florida Independent Living Council and Florida Association for Centers for Independent Living - at the Emergency Operations Center.

#### Florida Unemployment Updates

Governor Ron DeSantis, by Executive Order 20-104, has suspended the biweekly "actively seeking work" reporting requirement. This means, beginning

April 16, claimants do not need to re certify your weeks bi-weekly to receive your Reemployment Assistance benefits.
