

CLEARANCE INSTRUCTIONS FOR CHILD ADVOCATES VOLUNTEER ATTORNEYS

The Pennsylvania Child Protective Services Law requires that volunteers working with children have clearances. If you plan to volunteer, please complete the volunteer clearance process by following these steps:

PA STATE POLICE CRIMINAL RECORD CHECK (free for volunteers)

1. Go to: <https://epatch.state.pa.us/>.
2. Click on “New Record Check (Volunteers only).”
3. Complete the “Record Check Request Form” and click on “Enter This Request.”
4. On the next screen, you do not need to enter any information. Click on “View Queued Record Check Requests(1)”
5. On the next page, “Record Check Request Review,” click on “Submit.”
6. Click on the Control # (Starts with R).
7. Click on “Certification Form” and print/save form.
8. Please submit certificate to *Child Advocates*.

PENNSYLVANIA CHILDLINE CHILD ABUSE HISTORY CLEARANCE (free for volunteers)

1. Before you begin, you should have the following information readily available:
 - a. Addresses where you have previously lived (since 1975)
 - b. Names of all individuals with whom you have lived
 - c. Any previous names you have used or have been known by
2. Go to <https://www.compass.state.pa.us/cwis/public/home>
3. Click on “Create A New Account.”
4. Fill out the form to create your Keystone ID.
5. Retrieve your temporary password.
6. Go to <https://www.compass.state.pa.us/cwis/public/home> and click on “Login.”
7. Read the Disclosure and click “Continue.”
8. Login and change your password.
9. Login in with new password.
10. Under “Application Purpose,” check “Volunteer.” Volunteer Category is “Other” and Agency Name is “Support Center for Child Advocates.”
11. Fill out your personal information, previous addresses and names of household members.
12. Sign.
13. Click “Finalize” and “Submit Application.”
14. Your application will be processed, and within 14 days you will receive an email notification to log in to your account and view the outcome/result of the application.
15. Print certificate.

FBI CRIMINAL HISTORY CLEARANCE INSTRUCTIONS (\$22.60 for volunteers)

*** A volunteer that has been a Pennsylvania resident continuously for the past 10 years, is not required to obtain an FBI Clearance but must swear or affirm in writing that he/she is not disqualified from service based upon a conviction of an offense listed in 23 Pa.C.S. §6344 (c). If applicable, please submit the attached Disclosure Statement to Child Advocates.*

1. Go to: <https://www.identogo.com/>
2. Click on “Get Fingerprinted.”
3. Select “Pennsylvania.”
4. Select “Digital Fingerprinting.”
5. Enter Service Code “1KG6ZJ.”
6. Select “Schedule or Manage Appointment.”
7. Fill out the form
8. Choose the Identogo site you would like to go to.
9. Select date and time or check “Walk In.”
10. Click “Done.”
11. Go to the Identogo site. Be sure to bring proper documentation (specified on website).
12. Once you receive the FBI clearance certificate, please submit certificate to *Child Advocates*.

DISCLOSURE STATEMENT APPLICATION FOR VOLUNTEERS

Required by the Child Protective Service Law 23 Pa. C.S. Section 6344.2 (relating to volunteers having contact with children)

I swear/affirm that I am seeking a volunteer position and **AM NOT** required to obtain a certification through the Federal Bureau of Investigation (FBI), as:

- the position I am applying for is unpaid; **and**
- I have been a resident of Pennsylvania during the entirety of the previous ten-year period.

I understand that if I have not been a resident of Pennsylvania during the entirety of the previous ten-year period, but have received certification from the FBI since establishing residency, I must provide a copy of the certification to my employer and am not required to obtain any additional FBI certifications.

I swear/affirm that, if providing certifications that have been obtained within the preceding 60 months, I have not been disqualified from service as outlined below or have not been convicted of an offense similar in nature to a crime listed below under the laws or former laws of the United States or one of its territories or possessions, another state, the District of Columbia, the Commonwealth of Puerto Rico or a foreign nation, or under a former law of this Commonwealth.

I swear/affirm that I have not been named as a perpetrator of a founded report of child abuse within the past five (5) years as defined by the Child Protective Services Law.

I swear/affirm that I have not been convicted of any of the following crimes under Title 18 of the Pennsylvania consolidated statutes or of offenses similar in nature to those crimes under the laws or former laws of the United States or one of its territories or possessions, another state, the District of Columbia, the Commonwealth of Puerto Rico or a foreign nation, or under a former law of this Commonwealth.

I swear/affirm that I have not been convicted of a felony offense under Act 64-1972 (relating to the controlled substance, drug device and cosmetic act) committed within the past five years.

I understand that I shall not be approved for service if I am named as a perpetrator of a founded report of child abuse within the past five (5) years or have been convicted of any of the crimes listed above or of offenses similar in nature to those crimes under the laws or former laws of the United States or one of its territories or possessions, another state, the District of Columbia, the Commonwealth of Puerto Rico or a foreign nation, or under a former law of this Commonwealth.

I understand that if I am arrested for or convicted of an offense that would constitute grounds for denying participation in a program, activity or service under the Child Protective Services Law as listed above, or am named as perpetrator in a founded or indicated report, I must provide the administrator or designee with written notice not later than 72 hours after the arrest, conviction or notification that I have been listed as a perpetrator in the Statewide database.

I understand that if the person responsible for employment decisions or the administrator of a program, activity or service has a reasonable belief that I was arrested or convicted for an offense that would constitute grounds for denying participation in a program, activity or service under the Child Protective Services Law, or was named as perpetrator in a founded or indicated report, or I have provided notice as required under this section, the person responsible for employment decisions or administrator of a program, activity or service shall immediately require me to submit current certifications obtained through the Department of Human Services, the Pennsylvania State Police, and the Federal Bureau of Investigation, as appropriate. The cost of certifications shall be borne by the employing entity or program, activity or service.

I understand that if I willfully fail to disclose information required above, I commit a misdemeanor of the third degree and shall be subject to discipline up to and including denial of a volunteer position.

I understand that certifications obtained for the volunteering purposes can only be used for that purpose and cannot be used for employment purposes.

I understand that the person responsible for employment decisions or the administrator of a program, activity or service is required to maintain a copy of my certifications.

I hereby swear/affirm that the information as set forth above is true and correct. I understand that false swearing is a misdemeanor pursuant to Section 4903 of the Crimes Code.
