AN 'INTRO TO THE MAIN ROAD' MAP RALLY

This rally is to be run in accordance with the 1982 RRR'S as amended by these instructions (however, all necessary information is contained in these instructions).

Following the course:

Priority list: At each intersection the course you are to follow is determined by the first priority below that applies:

1. Execute a Numbered route instruction that directs a unique course, if it does not direct the same course as number 2 below.
2. Follow the Main Road.

At each intersection the Main Road is determined by applying the following list of determinants in order (beginning with A). The first one that directs a unique course is the Main Road:

- A. ONTO The main road is the road that the execution of the course directing action of the instruction has directed the contestant to travel upon by use of the term ONTO and the designation. The designated road is the main road at each intersection where ONTO is applicable until a course directing action is executed. The terms Right, Left, Turn and Straight are course directing actions; execution of those terms MUST result in following a course other than the Main Road.
- B. CURVE ARROWS The main road is the road leaving an intersection as determined by official highway block on yellow curve arrow sign(s) -- black on green here
- C. PROJECTION The main road is that single road leaving the intersection and having no stop sign or yield sign at the intersection.
- D. RIGHT AT T The main road is the road that goes to the right at a T.
- E. STRAIGHT AS POSSIBLE (SAP) The main road is the road that appears to go as directly ahead as possible through an intersection.

Conventions: Both paved and unpaved roads exist. Numbered streets (such as 11TH) and numbered county roads (such as COUNTY 11) will be referenced by their numbers only (11 in both cases).

ROUTE INSTRUCTIONS

0.00 1. North at "START".
0.10 2. Left.
3. Right at Fuss Road.
4. Left.
5. Right onto Freund.
6. Right onto Park Place.
7. Left after T.
8. Left onto Starr Path.
9. Left at T.
10. Left at Stop.
11. Turn onto 42.
12. Left.
13. Turn toward control.

an explanation of following the route, intersection by intersection, is on the back of the map.

EXPLANATION OF MAP RALLY -- intersection by intersection

Some abbreviations are used in this explanation to minimize space:

MR Main Road; Str - Straight; #N - route instruction number N;
*** indicate a major intended trap.

Left @ Guerino & Freund by #2 - MR was Str by PROTECTION.

Str @ Starr Path by MR SAP.

Str @ Park Place by MR SAP.

Right @ Freund & Brian by MR RIGHT AT T.

Str @ Starr Path by MR SAP.

Str @ County 42 by MR SAF (note that County 42 only goes right; another sign identifies Douglas as only going left; Brian ends here and County SS starts here and goes straight ahead).

*** Right @ County SS & Fuss by MR PROTECTION (not #3).

Right @ Fuss & Park Place by #3 (if you're upon the road designated in the instruction, you are AT it) - MR was Str by SAP.

Left @ Park Place & County 42 by #4 - MR was RIGHT AT T.

Str @ Park Place by MR PROTECTION. SAP

Right @ County 42 & 42nd St by MR PROTECTION.

Right @ 42nd St & Guerino by MR RIGHT AT T.

Right @ Guerino & Freund onto Freund by #5 - MR was Str by PROTECT.

Str @ Starr Path by MR ONTO.

Right @ Park Place & Freund onto Park Place by #6 - MR was Str ONTO.

Str @ Starr Path by MR ONTO.

*** Left @ Park Place & County 42 by MR CURVE ARROWS (not right by MR Right at T; however, this is the T referenced in #7).

*** Right @ County 42 & Park Place by MR ONTO (not Str by MR SAP; even though you've executed part of #7 by observing the T, until you've executed the course directing action 'Left' you're still ONTO Park Place).

Left @ Park Place & Fuss by #7 - MR was RIGHT AT T. (you're no longer ONTO Park Place).

Left @ Fuss & County SS by MR PROTECTION.

Str @ County SS & County 42 by MR SAP.

Left @ Brian & Starr Path onto Starr Path by #8 - MR was SAP.

Str @ Park Place by MR ONTO.

Left @ Starr Path & Freund by #9 - MR was RIGHT AT T.

Left @ Freund & Guerino by #10 - MR was RIGHT AT T.

*** Left @ Guerino & 42nd St by #11 - MR was SAP (under Conventions in the instructions, it said a number in the route instructions could identify a street or county road, so that 42 can be 42nd St or Cty 42; you reached 42nd first).

*** Left @ 42nd St & County 42 by MR PROTECTION; (not by #12).

Left @ County 42 & Park Place by #12 - MR was Str by ONTO.

Str @ Starr Path by MR SAP.

Right @ Park Place & Freund by MR RIGHT AT T.

Right @ Freund & Brian by MR RIGHT AT T.

Str @ Starr Path by MR SAP.

Str @ County 42 by MR SAP.

Right @ County SS & Fuss by MR PROTECTION.

Str @ Park Place by MR SAP.

Left @ Fuss & Lumpy Lane by #13 - MR was SAP.
