Deadline for abstract submissions is May 26, 2025, 11:59 pm EST

Submit an **original study, quality improvement/assurance project, or narrative review/comprehensive literature review** for consideration for **poster presentation** at the OSRC State Meeting.

Abstracts of **Original Studies** must include:

**Title:** Concise description of the study; do not include any brand or manufacturer names in the title.

**Background:** A statement of the research question or hypothesis, and the supporting rationale.

**Methods:** Description of the research design in sufficient detail to permit judgment of its validity. Must indicate statistical tests used. For studies involving human subjects, *must* indicate that Institutional Review Board (IRB) approval was obtained.

**Results:** Research findings with data and statistical analysis.

**Conclusions:** Interpretation of the results.

**Disclosures:** All authors' relations with industry for the previous 2 years must be disclosed.

Abstracts of **Quality Improvement/Assurance projects** must include:

**Title:** Concise description of the project; do not include any brand or manufacturer names in the title.

**Background:** A statement of the problem or improvement in process of care addressed.

**Methods:** Description of the project design in sufficient detail to permit judgment of its validity. Must include a statement of the data analysis used. [Please note: If the project involves human subjects, Institutional Review Board (IRB) approval may be required. Please consult local IRB for guidance.]

**Results:** Project findings with findings from data analysis.

**Conclusions:** Interpretation of the results.

**Disclosures:** All authors' relations with industry for the previous 2 years must be disclosed.

Abstracts of **Narrative Reviews/Comprehensive Literature Reviews** must include:

**Title:** Concise description of the review; do not include any brand or manufacturer names in the title.

**Background:** A statement of the problem addressed and objective of review. Description of importance and timeliness of topic.

**Summary of Findings or Observations:** Brief summary of results of review.

**Conclusions:** Interpretations of the findings or observations.

**Implications:** Potential effects or suggestions for clinical practice.

**Disclosures:** All authors' relations with industry for the previous 2 years must be disclosed.

**Important:** The abstract is the *only* evidence by which the reviewers can decide whether the author should be invited to present at the OSRC State Meeting. Give specific information. Do not write general statements such as "Results will be presented" or "Significance will be discussed."

Carefully read the information below and make sure your abstract meets **ALL** requirements.

### **Guidelines for Authors**

- **Abstracts that do not follow the guidelines will not be reviewed.**
- Abstracts must be written and presented in English.
- The abstract may have been presented previously at a national or international meeting.
- Abstracts may have one clear, concise table or figure.
- Common abbreviations may be employed in the text of the abstract without explanation.
- Total word count for the abstract may not exceed 300 words (this does not include the title or authors).
- Abstracts submitted by the deadline will be subjected to peer review. Incomplete abstracts will not be reviewed. Each abstract will be evaluated on merit and originality.
- Notification of abstract acceptance or rejection will be sent via e-mail to the presenter by June 30, 2025. The decision is final and cannot be appealed.
- Notification to presenter of accepted abstract will include date, time, and location for the presentation.
- No changes may be made to the authors, presenter, or abstract after June 30, 2025.

### **Submit Your Abstract**

- The submission deadline is May 26, 2025. No extensions will be granted.

- Submission of an abstract constitutes the author's commitment to present the abstract as accepted.

### **Conflict of Interest**

- Abstracts submitted by industry or their representatives will NOT be accepted.
- ALL authors must disclose all industry relations for the previous two years. It is expected that some authors will have financial and other ties to commercial entities related to products, services, or other aspects of the abstract, either at the time of submission or previously. Potential conflicts of interest are not considered unethical. However, failure to fully disclose such potential conflicts is unethical.
- Studies conducted in an industry laboratory must be disclosed.
- Abstracts will not be accepted if ghost written.
- Abstracts will not be accepted if there is an appearance of industry bias, whether or not conflict of interest has been disclosed.

## **Presentation Guidelines**

- Presenters must be OSRC/AARC members.
- Presenters must register as OSRC State Meeting attendees (daily registration and student rates are available). All fees and expenses associated with the preparation, submission, and presentation of abstracts including, but not limited to, travel, accommodations, and meeting registration, are the responsibility of the author/presenter.
- Presenters are expected to arrive on time for their presentation. Presenters are expected to attend the entire poster presentation session at the OSRC State Meeting.
- The poster presentation will be comprised of two parts. Presenters are required to participate in both parts. The moderator will provide guidance on the timeline for each part on the day of the presentations.
  - Part One of the poster presentation session will include time at the physical poster to discuss the study, project or review with attendees.
    - Display boards and push pins will be provided to display the physical poster. Maximum poster size is 48 inches wide and 36 inches tall.
  - Part Two of the poster presentation session will include 5 minutes per presenter at the podium to provide an overview of the study, project or review and to answer questions from the audience or moderator.
    - Presenters are required to submit a digital file of the poster to Sarah Varekojis ([Varekojis.16@osu.edu](mailto:Varekojis.16@osu.edu)) by July 28, 2025 for display during the podium presentation.
- A substitute presenter will not be allowed without prior written permission.
- All industry relations by all authors for the previous two years must be disclosed on the poster. Commercial logos are prohibited from appearing on the poster. Institutional logos are permitted on the poster.
