The children have been doing a great job following this rule so far this school year, and we appreciate your cooperation!

Parents are once again being asked to wait outside the building for pick-up and drop-off. Please continue to call the site phone number (518)227-5883 when you arrive, and a staff member will come to the door! You can also feel free to call the site phone during program hours if you have any questions! We know changes to rules and procedures have been continuous due to our new normal, so please do not hesitate to ask any questions you may have.
