As you are probably aware, throughout the pandemic HRSA implemented numerous RHC funding and supply programs. Please read below for updates about each program and to be reminded of important deadlines!

Still Accepting New Enrollees:

COVID-19 Testing Supply Program

This program distributes free COVID-19 supplies to RHCs! Clinics can order at-home COVID-19 tests, N95 masks, point-of-care analyzers, and analyzer strips on a weekly basis. Vaccine Distribution Program

This program allocates free COVID-19 vaccines to RHCs! RHC COVID-19 Testing and Mitigation (RHCCTM) Program

This program automatically allocated \$100,000 to RHCs for COVID-19 testing and mitigation efforts beginning in June of 2021. RHC COVID-19 Testing (RHCCT) Program

The RHCCT Program period has officially ended! This program allocated \$49,461.42 per RHC in May of 2020 to support testing efforts. As of Mar 2, 2022, all testing reporting, fund returns, and closeout requirements were due. If you are aware that your organization is out of compliance, please become compliant immediately. If you are unsure whether your RHC has completed all the necessary steps, please check your inbox for an important email from mo.sullivan@narhc.org, or email RHCCOVIDreporting@NARHC.org with any questions. As a reminder, if your organization experienced a change of ownership or a TIN change, you must complete reporting under the TIN that was originally paid.

Vaccine Confidence Program

The grant deadline is approaching! However, many RHCs have not yet drawn down on their funds. All funds must be used by June 30, 2022, unless your clinic applies for and is granted a No Cost Extension (NCE) through HRSA Electronic Handbooks (<u>https://bit.ly/3uE4SPL</u>).
