

## **2019-2020 LA LIAISON BOARD NOMINATIONS OPEN**

The current La Liaison PTO board is officially accepting nominations for the 2019-2020 school year La Liaison PTO board.

As a PTO board member, you will be assisting with a variety of activities throughout the school year and attend monthly board meetings. PTO organized activities are geared towards building community and raising funds that will be used to enhance the school.

The board is comprised of at least 7 members and at most 15, all parents of current Lycée Français students, ideally representing elementary school, middle school and high school. In addition there will be an English teacher representative and a French teacher representative.

Below is a brief description of each position:

President: The President is the chief executive officer of La Liaison and supervises and controls the business and affairs of La Liaison, seeing that all orders and resolutions of the Board of Directors are carried into effect. The President presides over all meetings of the Board of Directors, the Executive Committee, and the general membership.

Vice-President: The Vice-President shall, in the absence of the President, perform the duties and exercise the power of the President, and performs other duties as required to conduct meetings of the Board of Directors, the Executive Committee, or the general membership and oversees the affairs of La Liaison.

Secretary: The Secretary keeps a recording of minutes of the Board of Directors, the Executive Committee, or the general membership, maintains the corporate records and seal of La Liaison and performs other similar duties as assigned by the Board of Directors.

Treasurer: The Treasurer oversees La Liaison's funds and assets, including all corporate banking accounts, and keeps full and accurate accounts of receipts and disbursements in books belonging to La Liaison and deposits all monies and other valuable effects in the name and to the credit of La Liaison.

General Directors: Responsible for the management and control of the affairs, activities, and property of La Liaison, Directors are requested to chair at least one PTO sub-committee, and regularly attend all Board and General La Liaison meetings and events.

Nominations will be accepted until the end of the PTO General Meeting on April 24<sup>th</sup>. Depending on the number of nominations for each position, an election may take place after the nomination period closes.
