





Critical Race Theory and Culturally Responsive Teaching

To move forward we have to look back because our past informs our present. Critical Race Theory (CRT) is a collection of historical experiences. When scholars approach history honestly and equitably, they can inform students in classrooms throughout the world of the experiences for all races. Through this lens students can learn and be informed of the actual occurrences which drive our current events and inform us of what occurred and why.

CRT, nevertheless, is not a new concept. Fox News raised the concern that (CRT) has become a new boogie man for people unwilling to acknowledge our country's racist history and how it impacts the present. In the 1970's and 80's, legal scholars Derrick Bell, Kimberlé Crenshaw, and Richard Delgado examined legal framework and critiqued how it is constructed, institutionalized, and perpetuated in American Society. These scholars would lay the framework for what we now know as CRT. In addition to CRT, a newer idea of implementing inclusion and racial solidarity has emerged, Culturally Responsive Teaching.

While discussion is at an all-time high surrounding (CRT) Dr. Gloria Ladson-Billings, president of the National Academy of Education, has created Culturally Responsive Teaching. Dr. Ladson-Billings posits that a student-centered approach recognizes the importance of including student's cultural references in all aspects of learning. This method of education was introduced with the intention of providing safer environments for minority students in their classrooms. The Illinois State Board of Education approved it in December of 2020 with State superintendent Dr. Carmen I. Ayala stating, "Every student deserves to feel welcome, included, and accepted at school and to see their cultural identity and experiences affirmed and represented in all aspects of their educational journey".

August Events:

Political Action

Since January, 48 states have introduced **389 bills** that suppress voting rights. Parts of these bills include: **banning ballot drop boxes** and mail-in voting, **reducing early voting** days and hours, restricting who can get a mail-in ballot, prohibiting officials from promoting the use of mail-in ballots, and even **criminalizing** the distribution of water to voters waiting in the long lines these laws create. But on August 28, Americans Marched in Atlanta, Washington, D.C., Miami, Phoenix, and Houston to Demand an End to Voter Disenfranchisement Laws Sweeping the Nation!



Thankfully, the Political Action Committee was able to work with **state legislators** to **increase ballot access** and mail-in ballot access in Illinois this month. The U.S. House of Representatives **passed** the John R. Lewis Voting Rights Advancement Act on August 24th! [Now our efforts to fully pass this act are towards the U.S. Senate](#). The **National Action Network** is marching in Houston, Washington, **Atlanta**, Miami, **Phoenix**, and other cities across America to counteract voter suppression. In support of the march, the **Phi Beta Sigma Fraternity** donated **\$25,000!**.



WHAT	<ul style="list-style-type: none">Illinois has been allotted over \$1 billion in emergency rental assistance to keep families in homes while protecting landlords' rights.Tenants may qualify for up to \$25,000 in 12 months of back rent + 3 months of future rent, paid directly to the landlord.Tenants may also qualify for assistance with unpaid utilities and services like housing counseling, mediation, and legal aid.
WHO	<ul style="list-style-type: none">Tenants' household income must be less than 80% of the Area Median Income.¹Tenants must have experienced a financial hardship due to COVID-19.Proof of citizenship is NOT required.As a condition of receiving payment of rental arrears, landlords are prohibited from evicting the tenant for nonpayment of rent.²
NEXT STEPS³	<ul style="list-style-type: none">Rental assistance:<ul style="list-style-type: none">Refer litigants to local rental assistance programs in your jurisdiction.Direct litigants to illinoisrentalassistance.org where they can apply for rental assistance with an IDHS Service Provider in your area (now open) or directly through IHDA's Illinois Rental Payment Program (closed as of 7/28/2021 but may reopen in the fall).⁴Free legal help and mediation:<ul style="list-style-type: none">Inform tenants they can call (855) 631-0811, visit evictionhelpillinois.org, or text <i>EVICTION</i> to (844) 938-4280 to see if they qualify.⁵
