Members completing the criteria are reimbursed for State Association dues for the year the criteria is completed.

The certification is awarded on an annual basis. Application forms must be submitted for each application year.

All of the following criteria must be met to qualify. Check each item.

RPAC Trustees (meets 3 times per year)


