NEW BUSINESS

NALC/ELCA Discussion

Basis of discussion: We never had a congregational meeting about the changes proposed by the ELCA regarding the definition of All Means All and our relationship with the ELCA.

Ricky provided guidelines before discussion started.

The Bible is not clear or we would not be having this discussion today. We all have our own opinions and beliefs about denominations and within our church.

Pat put together the comparison between the two denominations. It was distributed among council members.

The issue: at the National Synod meeting, the ELCA agreed to ordain pastors of the same sexual orientation.

What some congregants want now is that discussion.

If we were to have a congregational meeting about our relationship with the ELCA, how could we best go about it?
