

Extremist Activity in the COVID-19 Webinar Q&A







On May 6, 2020, CNA and the National District Attorneys Association (NDAA) partnered with the Anti-Defamation League (ADL) to bring you a webinar focusing on extremist activity during the COVID-19 pandemic. During this webinar, we received a number of questions that we did not have time to answer. We have compiled these questions and our answers, as well as follow-up resources, in this document.

FOLLOW-UP RESOURCES

- During the webinar, there was a discussion on Zoombombing. Please see these ADL resources on what Zoombombing is, how to prevent it, how Zoom updated their security to fight zoombombing, and what steps to take during a Zoombombing incident.

QUESTION: CAN YOU DISCUSS "ASTROTURFING" IN THE ANTI-COVID-19 RESTRICTIONS MOVEMENT?

ANSWER: There have been a number of open source articles (i.e., in the Washington Post, the New York Times, the Guardian, NBC, and the Des Moines Register) alleging the role of well-funded pro-gun, anti-abortion, lobbying groups helping support and/or organize anti-lockdown protest efforts, in combination with a growing (yet still small) grassroots movement. ADL has particularly focused on the extremist elements drawn to these events. Although the earliest protests in March were largely organized by extremists, the latest rounds of rallies have been planned primarily by conservative activists, and have drawn extremists and non-extremists alike. Extremists and conspiracy theorists often use protests or rallies to spread their beliefs, but the pervasive and extensive media coverage of lockdown protests—which actually represent a minority opinion—has created an irresistible public platform. It has become clear that extremists view these events as an opportunity to share their dangerous messages. These rallies also serve as important opportunities for extremists to connect and develop new networks, and to lay the groundwork for future extremist activity.

QUESTION: ARE THERE ANY ERRORS OR GAPS IN THE MEDIA COVERAGE OF THIS SUBJECT?

ANSWER: The extensive media coverage focusing on these various protests nationwide has elevated and magnified the voices of those who are engaged in the lockdown protests. This can create the perception that they represent a substantial voice within the American public, when they actually represent a marginal US sentiment. Additionally, although the overwhelming majority of people drawn to these events are conservative activists and citizens expressing a range of concerns and fears about the economy and their livelihoods, these protests often are too broadly characterized as extremist in nature.

QUESTION: HOW DO YOU REPORT HATE ON FACEBOOK?

ANSWER: Facebook provides instructions for how to report a variety of content here. Per Facebook's Community Standards, hate speech is defined as "a direct attack on people based on what we call protected characteristics—race, ethnicity, national origin, religious affiliation, sexual orientation, caste, sex, gender, gender identity, and serious disease or disability." Facebook has released this information on how they decide when content is classified as hate speech and when content will be removed.

- With an increase of the use of Zoom in such places as courtrooms, which are open to the public, what are some steps that can be taken to help prevent Zoombombing?
