## **Terms**

A member of the CCTC Board of Directors may serve consecutive terms if responsibilities and annual commitments defined below are met.

# Responsibilities

The Board of Directors is the steward of the CCTC vision and the assets that secure and sustain CCTC's wellbeing and growth. The board is responsible for establishing procedure, overseeing finances, and formulating policy of the organization.

# **Annual Commitment**

A CCTC Board member is expected to fulfill these commitments:

- Be a member in good standing
- Attend a majority of board meetings each year (there are typical four quarterly board meetings); additional board meetings may be called at discretion of the Executive Committee
- Attend annual spring Retreat & Planning Conference
- Attend annual fall Workshop
- Actively participate in at least one CCTC Team (committee), or designate member of staff
- Generate new resources for CCTC by at least one of the following:
  - recruit one new CCTC member annually
  - identify and help secure one sponsor partnership annually
  - bring additional attendees to CCTC events
