

## MECHIRAT CHAMETZ/SELLING OF CHAMETZ

All chametz not destroyed must be given as a gift or must be sold to a non-Jew. The Rabbi is appointed as an agent of the seller of the chametz to sell it to a non-Jew. This procedure is not a legal fiction but a true sale in accordance with Talmudic and Secular Law.

**It is recommended to hand in the forms to Rabbi Shlomo Katz, in person. If you cannot return it personally, please e-mail it to the [asamole@aish.edu](mailto:asamole@aish.edu) OR fill the online form [HERE](#).**

- If you are **leaving your home** over Pesach and will be in a **time zone ahead of Toronto**, then you must have handed in your Chametz sales forms by **Tuesday, April 4, 2023, at 5:00 pm** to **Rabbi Shlomo Katz** by this point. Please email it to [asamole@aish.edu](mailto:asamole@aish.edu) OR fill the online form [HERE](#).
- If you are **staying home** over Pesach, then your Chametz sales forms must be handed to **Rabbi Shlomo Katz**, no later than **Wednesday, April 5, 2023, at 7:00 am**.

### NOTE:

Whiskey, beer, etc... are chametz and must be sold for Pesach!

All chametz in all your properties (local and foreign) must be included in your sale.

If this is a year where Erev Pesach falls out on Shabbat, please make sure that you have locked away all your chametz, except for that which you will use for your Shabbat meals!!

**Please be sure to print your name and address VERY CLEARLY.**

### **SHTAR HARSHAAH DELEGATION OF POWER OF ATTORNEY FOR SALE OF CHAMETZ**

Know ye that I, the undersigned, fully empower and permit Rabbi Shlomo Katz, and anyone he may subsequently authorize, to act in my place and stead, and on my behalf, to sell all chametz possessed by me (knowingly or unknowingly) as defined by the Torah and Rabbinic Law e.g. chametz, doubt of chametz and chametz on utensils. And to lease all places wherein chametz owned by me may be found, especially in the premises located at:

Rabbi Shlomo Katz has the full right to sell and to lease by transaction, as he deems fit and proper, and for such time which he believes necessary, in accordance with all terms and detailed forms as explained in the general authorization contract which has been given this year to Rabbi Shlomo Katz to sell my chametz.

This general authorization is made a part of the agreement. Also, I do hereby give Shlomo Katz full power and authority to appoint a substitute in his stead with full power to sell and to lease the chametz, as provided herein. The above given power is in conformity with all Torah Rabbinical regulations and laws, and in accordance with secular law. And to this I hereby affix my signature on the
