County Council Updates

OCTOBER-NOVEMBER-LEGISLATION

The following is noteworthy legislation voted on November 7.

MY LEGISLATION

CB55 Fiscal analysis provided by County Executive for specified legislation: A fiscal analysis from the bill's sponsor will help inform the deliberation process. This was originally proposed as a Charter Amendment (CR102-2020) but it failed on a 3-2 vote, needing four votes to appear on the 2020 ballot. **PASSED**

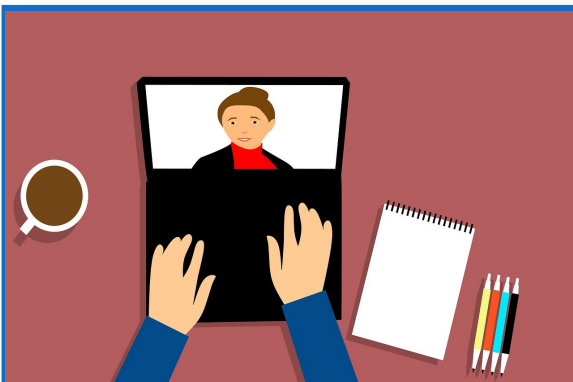
CB57 Removal of recommendations requirement from the Technical Staff Reports: I co-sponsored this legislation with Councilmember David Yungmann in an effort to make the Zoning Regulation Amendment process more deliberative for the Planning Board and for the Council. By removing the recommendation requirement, the Department of Planning and Zoning can provide pros and cons to aid

the appropriate decision-making body. I also sponsored an amendment, which passed unanimously, that requires the Technical Staff Reports to include specific requirements, including review of the petition's effect on environmental policy goals of the General Plan. **PASSED AS AMENDED**

OTHER COUNCILMEMBERS' LEGISLATION

CB56 Removal of APFO exemption for Turf Valley: I supported Councilmember Liz Walsh's proposed bill to remove the exemption that Turf Valley received from the school and roads tests required of most new subdivisions. The zoned schools for the phased development are at or near 100% capacity and are expected to exceed the capacity thresholds by 2024. With the removal of the exemption, some planned units will be required to wait in the school bin until new school capacity is added or until the maximum wait period is reached. **FAILED**

COUNTY EXECUTIVE'S LEGISLATION

TAO1-2021 Transfer of \$54,652,000 from contingency to the New Cultural Center:

This is one of the most expensive and ambitious projects presented to the current Council. The cultural center is also tied to an affordable housing project that has secured Federal and State aid prior to introduction of the project in the FY2021 Capital Budget.

The Council held multiple Worksessions on this project during the Budget deliberations that generated many unanswered questions about the financial viability of the primary private tenant, the annual operating costs that surpass revenues, and the timing of the project in relationship to other affordable housing amenities projects stipulated in the Downtown Columbia DRRRA.

In an effort to keep this Capital project alive but allow for more time to consider the details, I sponsored an amendment that put the project into contingency. A Worksession was held on October 26 to discuss new information but the NCC agenda item required rescheduling because we weren't able to include it in the allotted time. We revisited this legislation during the November 23 Worksession. **TABLED**

CB53 Turf Valley Elementary School land

purchase of \$6 million: A 10-acre parcel in the Turf Valley development will be purchased by the County for a new elementary

school site. In 2018, a letter of intent stated that the parcel would be 15 acres for the same sale price. HCPSS also currently has 41 acres on Marriottsville Road—Route 40 that has no current development plans. This was discussed in detail at the October 26 Worksession. **PASSED AS AMENDED**

CR151 BOE Capital Budget request FY2022:

This resolution enables the BOE to request State funding for proposed Capital projects. An amendment was pre-filed representing a recent BOE vote adding High School #14 (Troy Park) and ES #44 (West Columbia) to the FY2022-2031 Long-Range Master Plan. I testified in front of the BOE during their Capital Budget public hearing on the need for reinstating ES#44 into the Long-Range Master Plan after its omission in the original draft. I'm grateful to the BOE for making this critical adjustment. **PASSED AS AMENDED**

- **CB63** Prohibiting discrimination by County employees based on citizenship or immigration status, sponsored by Councilmember Opel Jones
- **CB61** Amending PlanHoward 2030 to include the Ellicott City Watershed Master Plan, sponsored by the County Executive
- **CR174** Authorizing the sale of the Flier Building in Columbia, sponsored by the County Executive

General Assembly: 2021 Session

State legislators released their plans to ensure social distancing procedures for the 2021 General Assembly convening on January 13. The plan will allow for House Delegates to meet as a body using a combination of virtual and in-person meetings. The Senate outlined a phased approach relying on virtual hearings with limited in-person debates, votes, and office meetings. Committee rooms and the Senate floor will be outfitted with plexiglass barriers. Sessions and hearings will be live-streamed. Public testimony will occur virtually, according to the Senate plan. An assessment for redetermination of school attendance area will be triggered if capacity exceeds 20%.

- **School Redistricting** – Public Testimony, Ho. Co. 7-21, by Senator Lam

Requiring the BOE to allow one or more members of a household to testify on the proposed redistricting plan if their school assignment is changed before the final vote.

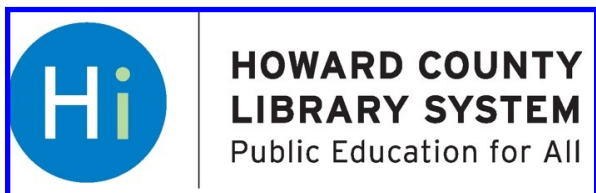
- **Howard County Board of Education** – School Safety Personnel, Ho. Co. 10-21, by Delegate Atterbeary

Requiring the BOE to develop a plan to implement the Maryland Center for School Safety guidelines that does not assign school resource officers to public school and uses adequate local law enforcement.

- **Commercial Building Excise Tax** – Board of Education Deferred Maintenance, Ho. Co. 11-21, by Delegate Atterbeary

Authorizing the County Council to impose different excise tax rates on commercial building construction with revenues used only for deferred maintenance needs of the BOE.

- **Howard County - Fee–in–Lieu of Moderate-Income Housing Units** – Prohibition, Ho. Co. 12-21, by Delegate Atterbeary

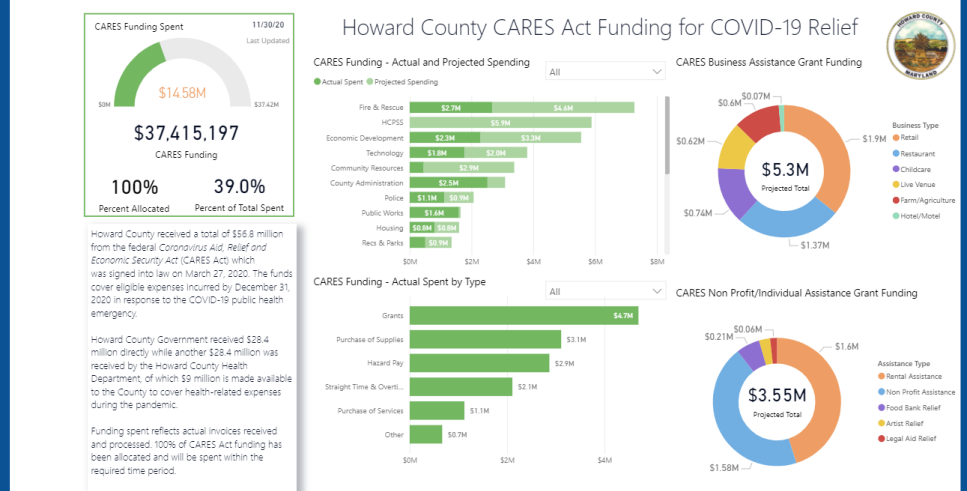

Applying for Energy Assistance

Energy Assistance is a year round program. You can apply at any time during the year, but you can only receive benefits once each year and must reapply each fiscal year (July- June).

If you are having trouble affording your utility or heating bill, you do not need a turn off notice to qualify for assistance. The Office of Home Energy Programs strongly encourages you to *apply for assistance before you receive a turn-off notice* so that funds can be applied to your account as soon as possible. All OHEP program eligibility is income-based and you do not need a turn off notice to qualify for assistance.

COLUMBIA NAMED “SAFEST CITY IN AMERICA”

Columbia was recognized as the “Safest City in America” by WalletHub for the third year in a row. WalletHub compared 182 cities, including the 150 most populated U.S. cities, plus at least two of the most populated cities in each state, across three criteria, home and community safety, natural-disaster risk, and financial safety. BEHAVIORAL HEALTH CRISIS FUNDING APPROVED

The Health Services Cost Review Commission (HSCRC) voted to fully fund the Greater Baltimore Regional Integrated Crisis System (GBRICS) Partnership. This funding award will invest \$45 million over five years to support behavioral health crisis response infrastructure and services in Baltimore City, Baltimore County, Carroll County, and Howard County. The goal of the project is to provide 24/7 access to high quality, effective, and timely care in the community, thus reducing unnecessary emergency department use and police interactions. CONGRATULATIONS DR. CARL PERKINS

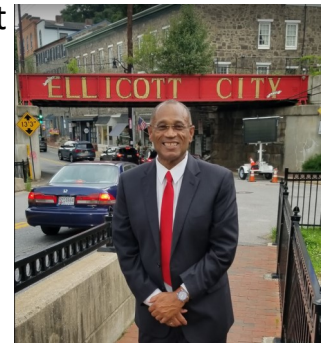

Out in the Community



Due to the COVID pandemic, I am no longer able to get out and about as much as I like. However, I did have the opportunity a few weeks ago to tour the new Howard County Circuit Courthouse, which, as you can see, is still very much under construction. The building sits on the same site as the Dorsey building on Bendix Road and will address technology and security challenges that were deficient in the old Circuit Courthouse in Ellicott City, which is 175 years old. The new Courthouse will house the Howard County State's Attorney, Sheriff, Bar Association, as well as the Maryland Public Defender, Clerk of the Court and Register of Wills, among others. There will also be a courtroom for a sixth judge, a larger and more comfortable jury assembly area, and a multi-level parking garage adjacent to the building. The opening of the new Courthouse is expected to be in July 2021.
