**Due by April 23<sup>rd</sup>:**

- **Remaining Payment (If deposit has been made)** \$250 per Scout, \$100 per adult

**Due by May 28<sup>th</sup>:**

- 2 copies of **BSA Medical Forms Parts A, B and C** with Part C signed by a doctor
- 2 copies of **medical insurance cards**
- If taking medication: ***Routine Drug Administration Form***
- If food allergies or dietary restrictions: ***Food Allergy and Dietary Accommodations form***

If the timing is such where your insurance is not due to pay for a well visit, most doctors' offices will fill out Medical Form Part C for a small fee of about \$10 to \$15.

**PARENT'S CONSENT AND AGREEMENT**
