



Q1 What are the THREE most important amenities to you or your family?

Q2 How frequently do you play golf?




Q3 Do you use the trails system in Hot Springs Village? (check all that apply)




Q5 If you answered “Yes” to question 4, should the Town Center be located near your neighborhood?

Q6 Would you support the development of land by the POA to add commercial offerings, create employment opportunities, and generate lease revenue for the POA?





Q8 Is your primary residence located in Hot Springs Village?


