2019 Start Smart Sports Development Program

ACTIVITY NUMBER: 20701 Section # S1

DESCRIPTION: The Start Smart Sports Development Program is a developmentally appropriate introductory sports program for children ages 3-5. The program prepares children and their parents for organized sports in a fun, non-threatening environment. Age appropriate equipment is utilized in the program. Parent-child groups perform motor skill tasks that gradually build confidence in children while they are having fun at the same time! The program works on developing the skills of **throwing, catching, batting, and kicking.**

AGES: The program is for Greenwich resident youth ages 3-5 **with a parent/guardian.** Must provide copy of birth certificate or passport of child if not submitted for past program(s).

Required Parent Orientation Meeting: **Tuesday, July 2 from 5:00-6:00 p.m.**
At Town Hall in the Cone Room, 2nd floor

SESSIONS: Tuesdays, July 9 to August 13. Rain/thunder make-up dates: August 20 and 27

TIME: 11:00 a.m. to 12:00 noon

LOCATION: Teufel Field at Byram Park. Park pass is required to enter Byram Park.

REGISTRATION DATES: Space is limited and registration is first come, first serve.

- **Online: Wednesday, May 1** – online registration is only available to Greenwich residents. To register online go to: www.greenwichct.gov/webtrac and select click on the Parks and Recreation logo.
- **Mail-in: Monday, June 3** - Application should not be postmarked earlier than June 3.
- **In-person: Monday, June 17** at the Parks & Recreation Office.

Greenwich residents are required to provide proof of residency once per calendar year for all Parks and Recreation programs. The primary family member is required to provide two current proofs of Greenwich residency. Family members participating in this program who are over 25 years of age require one current proof of Greenwich residency.

Acceptable proof documents with resident name, date and Greenwich address are as follows: Residential Lease; Utility bill (Gas, Electric, Water, Oil); Cable, Telephone, or Internet bill (not cell phone); Credit Card or Bank Statement (No Mortgage Statement); Driver's License or DMV CT State ID. Family members participating in this program who are under 25 years of age, require a copy of their birth certificate, passport, or guardianship on file.
