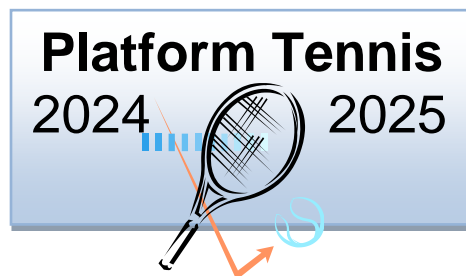

## 2024-2025 Platform Tennis Membership

**ACTIVITY NUMBER:** 41201

**DESCRIPTION:** MEMBERSHIP is required to play paddle tennis on the courts. Players who purchase a seasonal membership will be given 2 one-hour time slots per week. Reservations must be made at the time of purchase for the entire season. There is a \$25 seasonal fee for residents 65 and older – daytime use only - 2 senior OnePasses required to make reservations – registration form must be filled out in order to be given access to the courts.

**SCHEDULE:** The courts will be open Saturday, September 21, 2024 through Saturday, March 22, 2025.

During times of snow, the courts are a low priority and will be cleared after sidewalks and other access ways. The courts may not be cleared on weekends. Please do not attempt to clear the courts as the surface may become damaged or unsafe. 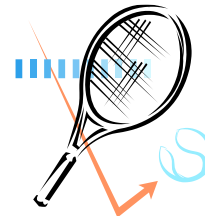

- **Online:** Opens Monday, July 1 – online registration is available to Greenwich Residents. To register online go to [www.greenwichct.gov/webtrac](http://www.greenwichct.gov/webtrac) and SIGN IN to your account. **2024** residency must be verified before applying for this activity. Visit: [www.greenwichct.gov/residency](http://www.greenwichct.gov/residency).
- **Mail-in for non-residents:** Begins Monday, July 15 – primary family members and all participating family members, over 25 years, must provide identification and proof of address. Participants under 25 years, require a copy of birth certificate or legal guardianship.

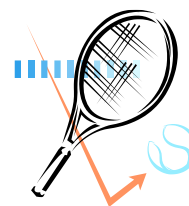

- Court location: Loughlin Avenue, Cos Cob (Court 1 is closest to the field/playground; Court 2 is closest to the tennis courts). Lights are on 7 days per week from dusk to 9 p.m. Reservations start on the hour 9 a.m. – 8 p.m. **\*The courts have gas heaters to be utilized only when needed and to reduce court time closures after ice and snow storms.**
- During times of snow, the courts are a low priority and will be cleared after sidewalks and other access ways. The courts may not be cleared on weekends. Please do not attempt to clear the courts as the surface may become damaged or unsafe. Call 203-861-6100 for weather/playing information or check [www.teamsideline.com/greenwichct](http://www.teamsideline.com/greenwichct).
- Players must wear tennis shoes while on the courts.
- Players are responsible for locking the courts. Please call and notify us if there is a light out or a problem at the courts.
- **Season Members** may reserve two 1-hour time slots per week (consecutive hours permitted).
- **Senior Citizen residents** with OnePasses may reserve courts one week in advance online. After login to your Parks and Recreation account at: [www.greenwichct.gov/webtrac](http://www.greenwichct.gov/webtrac), click on Court Reservations or select the court reservations button from the main page.
- Failure to arrive within 10 minutes of a reserved time slot will result in the forfeiture of the reservation, with the slot reverting to “open time”.
- During non-reserved/open time, players are asked to limit play to one hour if others are waiting.
- The full season member court reservations and open time slots will be posted at the courts and sent via email to all members. All reservations including those made weekly online by senior members are available by logging in online to your Parks and Recreation account at: [www.greenwichct.gov/webtrac](http://www.greenwichct.gov/webtrac).
- The last day of reserved use of courts will be March 22, 2025. The **season may be extended** if the courts are closed due to excessive loss of court time (snow/ice covered).
- Adult season members or senior OnePass holders may bring children ages 13 and under to play as long as the children have valid Park Passes.
- **The courts will be locked. Players will be responsible for locking up after use. The combination may be changed from time-to-time. Anyone found giving the combination to a non-registered player, will forfeit their use of the courts and no refunds will be issued.**
- Players must have some form of identification and must make it available when requested by Recreation Staff.
- The Recreation Division reserves the right to reserve time slots for programming purposes.
