# 2019 Fall Field Hockey

## Co-ed, Grades 1 - 8

**ACTIVITY NUMBER:** 30601

**DESCRIPTION:** An instructional program for grades 1 through 8. This program will focus on all the fundamentals of field hockey through practices and games. Games will be scheduled with other Town teams for grades 3 through 8 from the surrounding area, including Fairfield and Westchester Counties. **Participants in grades 1 and 2 will have a one-hour, weekly clinic on Sundays.**

**REGISTRATION:**

**Online:** Opens **Monday, July 22** - online registration is only available to Greenwich residents. To register online go to [www.greenwichct.gov/webtrac](http://www.greenwichct.gov/webtrac) and select "Activity Registration."

**Mail-In:** Begins **Monday, August 5** – application should not be postmarked earlier than August 5.

**In-person:** Begins **Monday August 19**– at the Parks and Recreation office. Non-residents may sign-up starting Monday, August 19. Registration closes Friday, August 30 or when the program has filled; space is limited.

**Greenwich residents are required to provide proof of residency once per calendar year for all Parks and Recreation programs.** The primary family member is required to provide two current proofs of Greenwich residency. Family members participating in this program who are over 25 years of age require one current proof of Greenwich residency. Acceptable proof documents with resident name, date and Greenwich address are as follows: Residential Lease; Utility bill (Gas, Electric, Water, Oil); Cable, Telephone, or Internet bill (not cell phone); Credit Card or Bank Statement (No Mortgage Statement); Driver’s License or DMV CT State ID. Family members participating in this program who are under 25 years of age, require a copy of their birth certificate, passport, or guardianship on file.

**For non-residents, the primary family member as well as all participating family members who are over 25 years of age must provide identification and proof of address. Non-resident participants under 25 years of age, require a copy of birth certificate, passport or guardianship.**

**AGE REQUIREMENT:** Must be entering 1<sup>st</sup> grade and not starting 9<sup>th</sup> grade by the start of school year.

**PROGRAM:** Program starts Sunday, September 8 and ends no later than November 10. All participants will play mostly on **\*Sundays** for a practice, scrimmage, or game scheduled. **\*Note: Changed to Sundays.** There could be an occasional away game on a Saturday, depending on the host team’s field availability. Greenwich will host all games and practices on Sundays. There may also be occasional **practices** scheduled during the week (Wednesday evenings) **for grades 3 - 8.**

**LOCATION:** Sunday practices and home games will be played on Benvenuto Field (turf) at **Cos Cob Park** (22 Sound Shore Drive, Cos Cob, CT). **Local travel** will be required for participants in **grades 3 – 8** for away games that are scheduled with other Town teams.

**STAFF:** Experienced staff will provide instruction and coaching. The Town of Greenwich is a member organization of the National Alliance for Youth Sports (NAYS) and provides certification to all coaches. All staff are required to complete a background check.



**TEAMS:** Participants will be placed on teams for games and scrimmages. Teams will be comprised of players in the grades/sections listed above. Special requests will not be guaranteed.

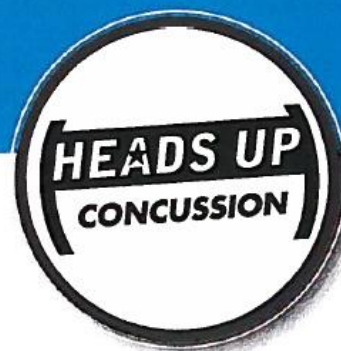

# PARENT & ATHLETE CONCUSSION INFORMATION SHEET



## WHAT IS A CONCUSSION?

A concussion is a type of traumatic brain injury that changes the way the brain normally works. A concussion is caused by a bump, blow, or jolt to the head or body that causes the head and brain to move quickly back and forth. Even a "ding," "getting your bell rung," or what seems to be a mild bump or blow to the head can be serious.

## WHAT ARE THE SIGNS AND SYMPTOMS OF CONCUSSION?

Signs and symptoms of concussion can show up right after the injury or may not appear or be noticed until days or weeks after the injury.

If an athlete reports one or more symptoms of concussion after a bump, blow, or jolt to the head or body, s/he should be kept out of play the day of the injury. The athlete should only return to play with permission from a health care professional experienced in evaluating for concussion.

### DID YOU KNOW?

- Most concussions occur without loss of consciousness.
- Athletes who have, at any point in their lives, had a concussion have an increased risk for another concussion.
- Young children and teens are more likely to get a concussion and take longer to recover than adults.

## SYMPTOMS REPORTED BY ATHLETE:

- Headache or "pressure" in head
- Nausea or vomiting
- Balance problems or dizziness
- Double or blurry vision
- Sensitivity to light
- Sensitivity to noise
- Feeling sluggish, hazy, foggy, or groggy
- Concentration or memory problems
- Confusion
- Just not "feeling right" or is "feeling down"

## SIGNS OBSERVED BY COACHING STAFF:

- Appears dazed or stunned
- Is confused about assignment or position
- Forgets an instruction
- Is unsure of game, score, or opponent
- Moves clumsily
- Answers questions slowly
- Loses consciousness (even briefly)
- Shows mood, behavior, or personality changes
- Can't recall events prior to hit or fall
- Can't recall events after hit or fall

## CONCUSSION DANGER SIGNS

In rare cases, a dangerous blood clot may form on the brain in a person with a concussion and crowd the brain against the skull. An athlete should receive immediate medical attention if after a bump, blow, or jolt to the head or body s/he exhibits any of the following danger signs:

- One pupil larger than the other
- Is drowsy or cannot be awakened
- A headache that gets worse
- Weakness, numbness, or decreased coordination
- Repeated vomiting or nausea
- Slurred speech
- Convulsions or seizures
- Cannot recognize people or places
- Becomes increasingly confused, restless, or agitated
- Has unusual behavior
- Loses consciousness (even a brief loss of consciousness should be taken seriously)

## WHAT SHOULD YOU DO IF YOU THINK YOUR ATHLETE HAS A CONCUSSION?

1. If you suspect that an athlete has a concussion, remove the athlete from play and seek medical attention. Do not try to judge the severity of the injury yourself. Keep the athlete out of play the day of the injury and until a health care professional, experienced in evaluating for concussion, says s/he is symptom-free and it's OK to return to play.
2. Rest is key to helping an athlete recover from a concussion. Exercising or activities that involve a lot of concentration, such as studying, working on the computer, and playing video games, may cause concussion symptoms to reappear or get worse. After a concussion, returning to sports and school is a gradual process that should be carefully managed and monitored by a health care professional.
3. Remember: Concussions affect people differently. While most athletes with a concussion recover quickly and fully, some will have symptoms that last for days, or even weeks. A more serious concussion can last for months or longer.

## WHY SHOULD AN ATHLETE REPORT THEIR SYMPTOMS?

If an athlete has a concussion, his/her brain needs time to heal. While an athlete's brain is still healing, s/he is much more likely to have another concussion. Repeat concussions can increase the time it takes to recover. In rare cases, repeat concussions in young athletes can result in brain swelling or permanent damage to their brain. They can even be fatal.
