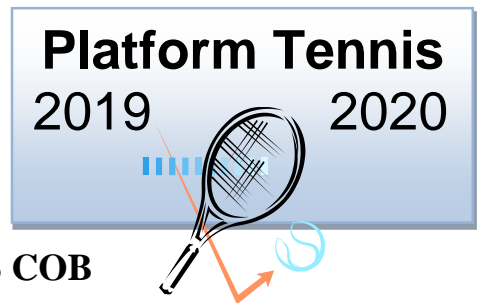

ACTIVITY NUMBER: 41201

DESCRIPTION: MEMBERSHIP is required to play paddle tennis on the newly refurbished courts. Players who purchase a seasonal rental will be given 2 one-hour time slots per week. Reservations must be made at the time of purchase for the entire season. There is a \$25.00 seasonal fee for residents 65 and older – daytime use only - 2 senior park passes required to make reservations – registration form must be filled out in order to be given access to the courts.

REGISTRATION:

- Online: Opens **Monday, August 19, 2019** – online registration is only available to Greenwich residents. To register online go to www.greenwichct.gov/webtrac and select “Activity Registration.”
- Mail-in: Begins **Tuesday, September 3, 2019** – Application should not be postmarked earlier than Sept. 3.
- In-person: Begins **Monday, September 16, 2019** – At the Parks and Recreation Office. Non-residents may sign-up starting September 16.

Greenwich residents are required to provide proof of residency once per calendar year for all Parks and Recreation programs. The primary family member is required to provide two current proofs of Greenwich residency. Family members participating in this program who are over 25 years of age require one current proof of Greenwich residency. Acceptable proof documents with resident name, date and Greenwich address are as follows: Residential Lease; Utility bill (Gas, Electric, Water, Oil); Cable, Telephone, or Internet bill (not cell phone); Credit Card or Bank Statement (No Mortgage Statement); Driver’s License or DMV CT State ID. Family members participating in this program who are under 25 years of age, require a copy of their birth certificate, passport, or guardianship on file.

For non-residents, the primary family member as well as all participating family members who are over 25 years of age must provide identification and proof of address. Non-resident participants under 25 years of age, require a copy of birth certificate, passport or guardianship.

SEASON: The courts will be open Saturday, September 28, 2019 through Friday, March 27, 2020.

There are no refunds and we do not pro-rate fees. Requests for credit will be considered if received in writing prior to the start of the program. There is a \$15.00 administrative fee for credits and a \$25.00 fee for any returned checks.

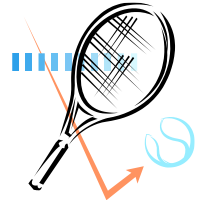

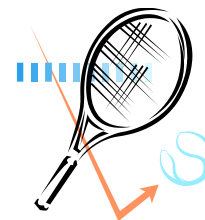


- Court location: Loughlin Avenue, Cos Cob (Court 1 is closest to the field/playground; Court 2 is closest to the tennis courts). Lights are on 7 days per week from dusk to 9:00 p.m. Reservations start on the hour 9:00 a.m. – 8:00 p.m. ****The courts have gas heaters to be utilized when needed and to reduce court time closures after ice and snow storms.***
- During times of snow, the courts are a low priority and will be cleared after sidewalks and other access ways. The courts will not be cleared on weekends. Please do not attempt to clear the courts as the surface may become damaged or unsafe. Call 203-861-6100 for weather/playing information or check www.teamsideline.com/greenwichct.
- Players must wear tennis shoes while on the courts.
- Players are responsible for locking the courts. Please call and notify us if there is a light out or a problem at the courts.
- **Season Members** may reserve two 1-hour time slots per week (consecutive hours permitted).
- **Senior Citizen residents** with park passes may reserve courts bi-weekly (call or e-mail) for two consecutive weeks. The reservations are for daylight hours only. The calendar week begins on a Saturday and continues through the following Friday. **ALL SENIOR PARK PASS CARD NUMBERS MUST BE GIVEN WHEN MAKING RESERVATIONS.** A season rental **must** be purchased to play during the evening hours and to have secured court times for the duration of the season.
- All reservations and cancellations may be made either by phone or email between the hours of 10:00 a.m. - 2:30 p.m. Monday through Wednesday. Phone: 203-618-7649, email: Recreation@greenwichct.org. Reservations will not be taken the weeks of Thanksgiving and Christmas.
- Failure to arrive within 10 minutes of a reserved time slot will result in the forfeiture of the reservation, with the slot reverting to “open time”.
- During non-reserved/open time, players are asked to limit play to one hour if others are waiting.
- The scheduled reserved and open time slots will be posted at the courts and sent via email to all members.
- The reservation phone line will close March 18, 2020. The last day of reserved use of courts will be March 27, 2020. The **season may be extended** if the courts are closed due to excessive loss of court time. (snow/ice covered).
- Adult season members or senior park pass holders may bring children ages 13 and under to play as long as the children have valid park passes.
- **The courts will be locked. Players will be responsible for locking up after use. The combination may be changed from time to time. Anyone found giving the combination to a non-registered player, will forfeit their use of the courts and no refunds will be issued.**
- Any lost court time due to snow, rain, or repairs, can be made up by calling the reservation line: 203-618-7649 or emailing Recreation@greenwichct.org. A reservation/rental must have been made in order for the time to be made up.
- Players must have some form of identification and must make it available when requested by Recreation Staff.
- The Recreation Division reserves the right to reserve time slots for instructional purposes, tournaments, league play, and Saturday/Sunday socials.

Proof of Greenwich residency is required once each calendar year for all Parks and Recreation programs. The Primary account holder is required to provide two current proofs of Greenwich residence. Acceptable forms of proofs with resident name and Greenwich address are as follows: residential lease, utility bill (Gas, Electric, Water, Oil), phone, internet and/or TV service bill (No Cell/Wireless Phone Bills), credit card or bank statement (No Mortgage Statement) or valid Driver's License or Connecticut State ID card. **ALL participants**, under 25, require a birth certificate or passport on file. **All non-residents must provide identification and proof of address.**

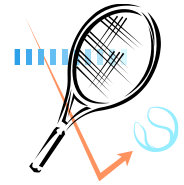
