2020 Summer Swim Programs

Group, Private and Semi-Private Lessons

LOCATION: Greenwich Pool in Byram Park, 4 Ritch Avenue

DATES: Mondays through Thursdays (rain dates on Fridays), July 6 through August 13. Group lessons run for three two-week sessions. See page 2 for specific dates and times. Private and semi-private lessons scheduled during the same times as group lessons.

AGES & PRE-REQUISITES: Lessons for youth ages 4 and up; must be toilet trained. See Goals and Guidelines for Group Swimming Lessons on page 3. Must provide copy of birth certificate or passport if not submitted for past program(s).

REGISTRATION: Open to Greenwich residents with a valid 2020 Park Pass. **Participants age 4 years must also obtain a 2020 Park Pass, although for no charge.** Children under 12 years of age must be accompanied at all times by a responsible adult, 18 years or older, with a resident Park Pass. Space is limited and registration is first come, first serve.

Private and Semi-private Lesson Registration begins June 15 online or in-person.

Group Lesson Registration begins:

- **No walk-in/in-person registration available**

We accept Visa, MasterCard, American Express and Discover credit cards for resident online registration. There are no refunds and we do not pro-rate fees. Requests for credit will only be considered if received in writing prior to the start of the program. There is a \$15.00 administrative fee for credits and a \$25.00 fee for any returned checks.

Greenwich residents are required to provide proof of residency once per calendar year for all Parks and Recreation programs. The primary family member is required to provide two current proofs of Greenwich residency. Family members participating in this program who are over 25 years of age require one current proof of Greenwich residency. **Family members participating in this program who are under 25 years of age, require a copy of their birth certificate, passport, or guardianship on file.**

Acceptable proof documents with resident name, date and Greenwich address are as follows: Residential Lease; Utility bill (Gas, Electric, Water, Oil); Cable, Telephone, or Internet bill (not cell phone); Credit Card or Bank Statement (No Mortgage Statement); Driver's License or DMV CT State ID.

GROUP LESSONS

DESCRIPTION: Youth swim lessons program of eight, one-half hour sessions. Classes will be held on Mondays through Thursdays, with a rain date of Friday the same week. See below for descriptions of each level of classes offered. Class schedule may be changed or cancelled according to enrollment and demand.

COVID-19 Program Adjustments

- We request only **ONE adult (parent/guardian) to accompany the participant to class. No additional adults or children, please.**
- Please do not arrive at the pool facility more than five minutes prior to the scheduled class time.
- Participants should come dressed in swim attire to limit time spent in the public restrooms.
- Class sizes will be reduced with maximum numbers allowed listed on page 3.
- **For Goldfish and Level I classes, we will be requiring the parent's/guardian's participation in the water with the child. This will allow for the child to get hands on instruction from their guardian instead of the Swim Instructor. For Level II and above, guardian's participation in the water may be requested at the discretion of the Head Swim Instructor.**
- Swim Instructors will be wearing face masks.
- No sharing of goggles.
- Any swim aids used in class will be sanitized in a chlorine-water solution after each use.
- Parents/guardians waiting on pool deck should wear masks and practice social distancing.

GOALS and GUIDELINES for SWIMMING LESSON CLASS LEVELS

PRE SCHOOL "GOLDFISH"	AGES 4-5 Water entrance/exit, buoyancy, bubble blowing, submerge head, bobbing, finning, kicking, floating-back/front, roll front to back and back to front, jump into the pool, open eyes under water. GUARDIAN REQUIRED IN WATER WITH CHILD
LEVEL I	AGES 6 AND UP INTRODUCTION Water entrance/exit, buoyancy, bubble blowing, submerge head, bobbing, finning, kicking, floating-back/front, roll front to back and back to front, jump into the pool, open eyes under water. Treading, rhythmic bobbing, gliding, position changing, arm/leg action. GUARDIAN REQUIRED IN WATER WITH CHILD
LEVEL II	AGES 6 AND UP FUNDAMENTALS Child should have passed Level I All of the above plus: Introduction to rhythmic breathing, rotary breathing, longer gliding/floating, alternating arm/leg actions, combined arm/leg actions.
LEVEL III	AGES 6 AND UP STROKE DEVELOPMENT Child should have passed Level II All of the above plus: Deep water jump and recovery, seated head first entry, survival floating, position changing in deep water, introduction to all strokes EXCEPT butterfly.
LEVEL IV	AGES 6 AND UP STROKE IMPROVEMENT Child should have passed Level III All of the above plus: Butterfly stroke.

PRIVATE & SEMI-PRIVATE LESSONS

ACTIVITY NUMBER: 207021 Section PS

DESCRIPTION: One-on one (or two-on-one for semi-private) swim instruction with Town of Greenwich swim instructors can be scheduled with our Head Swim Instructor, Scott. Contact Scott at the pool during the dates and times listed below or by email beginning June 15 at ScottKarsenAquatics@icloud.com Lessons will be individually tailored based on the swim level of the participant. Lessons are for one-half hour each and, based on the availability of instructors, may be scheduled for specific half-hour time slots. Please check availability prior to registering and paying for a private lesson. Lesson must be paid in advance; show receipt to Head Swim Instructor.

TIMES: Depending on the availability of the instructors, lessons may be scheduled during group lessons times. Registration begins June 15 online or in-person.

FEE: \$50.00 per participant for a private half-hour lesson, payable to "Town of Greenwich".
\$80.00 for two participants (\$40.00 each) for a semi-private half-hour lesson.

GENERAL INFORMATION FOR ALL LESSONS

WEATHER: For weather cancellation, please call 203-861-6100 (Recreation Hotline). Lessons may be held during light rain, but cannot be held during thunder or lightning. In the event of thunder or lightning, the pool must be closed for thirty minute intervals for each occurrence.

THE POOL IS NOT OPEN TO THE PUBLIC UNTIL 11:00 A.M. ALL POOL FACILITY RULES MUST BE FOLLOWED BY THOSE ENROLLED IN SWIM LESSONS, including but not limited to the following:

- Any new facility restrictions in place as a result of COVID-19 must be adhered to.
- All persons wishing to enter the pool area, whether they plan to swim or not, must present a park pass.
- Children under 12 years of age must be accompanied at all times by a responsible adult, 18 years or older at a ratio of 1 adult to no more than 6 children.
- In the case of thunder or lightning, all patrons must clear the pool water and deck and must return to their cars for protection. The pool will not reopen until 30 minutes after the last rumble of thunder or sight of lightning, as determined by lifeguards.
- Blankets and towels may be taken to open areas around the pool outside the perimeter line only. A clear path must be maintained around the perimeter of the pools at all times. No outside chairs are allowed in facility; benches and wall seating are available.
- No umbrellas, no sun shelters, and no pop-up tents are permitted at the pool complex.
- Coolers are not permitted in the pool area. No food or beverage is permitted in the pool area, except beverage in plastic water bottles. Food from the concession area may not be brought into the fenced in pool complex. NO GLASS container of any type is permitted in the pool complex.
- The use of the pool for swim instruction, whether group or individual, is permitted only by Parks and Recreation Department staff and according to Department policy.
- The Parks and Recreation Department reserves the right to change existing rules; regulate the hours of use; enact new rules to meet the changing conditions at the pool; clear the pool area during any threat of hazardous conditions; or close a portion of the pool for special events, programs, or staffing needs. **The Pool Staff has the final decision regarding all pool rules.**
