ARKANSAS ROAD TEAM NOMINATIONS DUE JULY 25TH



The Arkansas Trucking Association is accepting nominations for the Arkansas Road Team through July 25.

The Arkansas Road Team is comprised of professional drivers who are dedicated to safety, courtesy and responsibility. They serve as ambassadors for the trucking industry, relating its commitment to safety and its importance to the economy.

This complimentary outreach program of the Arkansas Trucking Association serves as a public education service to address highway safety and to educate the motoring public on safe driving, especially younger drivers.

Drivers selected for the Arkansas Road Team will conduct Share the Road presentations, demonstrate safety best practices and discuss issues of importance to the industry, including careers, regulatory/legislative concerns, etc. at schools and other events around the state.

Motor carriers should limit nominations to three drivers. Finalists will be asked to participate in a panel interview and conduct a brief presentation at the Arkansas Trucking Association office in Little Rock on September 10th.

Nominee Requirements

- Be employed as a full-time truck driver, domiciled in Arkansas.
- Have an outstanding safe driving record.
- Be able to communicate a clear and convincing commitment to safety and professionalism with an appearance and demeanor that represents the trucking industry well.
- Agree to be available upon reasonable notice for presentations and other industry events within the state, typically two-three times per month.
- Serve in an active capacity for a period of two years, with alumni/reserve status thereafter. This commitment may be extended beyond the 2-year term with the concurrence of the ATA, sponsoring member company and Road Team member.

Employer/Sponsor Requirements

- Be a member in good-standing of the Arkansas Trucking Association.
- Nominators must have authority to commit to his/her company's support of the program and should confirm the nominee's willingness to participate.
- Agree to compensate the driver's equivalent earnings/benefits during the time he/she is off work to accommodate a Road Team appearance. (ATA will pay relevant travel expenses.)
- Agree to provide power (using own company's driver) to pull ATA's Share the Road trailer when given reasonable notice, and when possible, without disruption to company operations.

Nomination Submission

- Nominations are limited to three drivers from one carrier and are due by July 25.
- Submit 1) completed nomination form, 2) copy of MVR, 3) details on past driving accidents/incidents and 4) a current
