Accordingly, the Receiving Party shall then be considered a "Plan Holder" and therefore, will receive copies of any addenda.

The delivery of electronic documents should not be construed to provide an express warranty or guarantee that all dimensions and details are exact. In the event of a discrepancy between the electronic documents and the hardcopy documents, the hardcopy documents provided by and received from the engineer shall prevail. Any use of this information is at the sole risk and liability of the user.

The delivery of the Plans and Specifications in electronic format is for the convenience of the Receiving Party. Nothing in this transfer should be construed to provide any right of the Receiving Party to rely on anything other than visual presentation of this electronic information. Electronic manipulation of the documents using electronic tools to obtain/extract additional information (such as dimensional information) not expressly shown on the documents is prohibited.

Any use of this electronic information is at the sole risk and liability of the user who is responsible for obtaining updated information to reflect any changes in the Plans and Specifications following the preparation date of this information. Receiving Party shall hold harmless to the maximum extent allowed by law the engineer and the Owner from any use of the electronic file(s) by the Receiving Party. **Receiving Party hereby agrees that these electronic files will not be transferred to any other person or entity.** Receiving Party hereby agrees that these electronic files will not be modified from the state at which the files are received and shall be used only for general convenience in affiliation with the project for which the files are associated.

INDEMNIFICATION AGREEMENT:

3. Furthermore, you shall, to the fullest extent permitted by law, indemnify and hold harmless the Owner, and MCI from all claims, damages, losses, and expenses, including attorney's fees arising out of or resulting from your use of these electronic files.
4. These electronic files are not Contract Documents. Significant differences may exist between these electronic files and corresponding hardcopy Contract Documents due to addenda, change orders or other revisions. In the event that a conflict arises between the hardcopy Contract Documents prepared by MCI and electronic files, the hardcopy Bid and Contract Documents shall govern. You are responsible for determining if any conflict exists. By your use of these electronic files, you are not relieved of your duty to fully comply with the Contract Documents, including and without limitation, the need to check, confirm and coordinate all dimensions and details, take field measurements, verify field conditions, and coordinate your work with that of other contractors for the project.
