## TTA SPOTLIGHT: PROSECUTION ASSESSMENT

A local county prosecutor's office within a PSN district recently participated in a *Prosecution Assessment* offered by the PSN TTA program. The goals and objectives of this assessment are to:

- Assess capacity to prosecute violent crime using federal and state law.
- Identify strengths, gaps, and enhancements needed in violent crime prosecutions.
- Identify local and national resources to improve successful prosecution results.

The office's motivation for participating in the assessment was to ensure that it was implementing best practices as it relates to the prosecution of violent crime cases. Subject matter experts John Skinner and Beth McGarry conducted this assessment virtually and the prosecutor's office plans to use the findings and recommendations from the assessment report in its annual review process.
