- 3) No cancellation fees or charges. All we require is 48 hours notice and your ATM will be removed. There are no install or removal fees, for any reason.
- 4) No maintenance or upgrades fees or charge (except vandalism). All service is done within 5 hours, 7 days a week, 365 days a year, from 7 am to 9 pm, within the Lower Mainland and southern Vancouver Island. All other regions receive service within 24 hours.
- 5) Complimentary ATM paper
- 6) No deposit or processing fees ever!
- 7) ABLE BC members get 100% of the ATM surcharge, no matter what you set the surcharge at. VI Banking will never raise your surcharge. Please ask for more details.
- 8) No communication (internet) costs to you. Please call for more information.
- 9) We process more cards than other providers from more card issuers globally.
