All participants must be at least 18 years of age or older. Participants must have a current 2020 City Utilities Boat Registration Permit on any non-motorized boat being used to participate in the event. Personal Flotation Devices are required for all participants. No motorized boats, all boats must be launched at the boat launch; all normal rules apply. (No swimming or alcohol)
