

Good afternoon,

Due to a technical error, the Statewide Laboratory Advisory Meeting was not recorded for April. Attached is a brief synopsis of the April meeting highlighting relevant announcements and DHHS updates. If you have any additional questions, please let me know. I apologize for any inconvenience.

1. Laboratory topics:

- a. Alison Keyser-Metobo, DHHS, wishes to remind all labs to submit all isolates of invasive *N. meningitidis* and *H. influenzae* to NPHL.
- b. Similarly, NPHL would like to remind all labs to submit isolates of *Legionella spp.* if cultured and identified in your laboratory.
- c. The NE-DHHS released a *C. auris* [HAN](#) on March 26th.
 - i. There have been 5 clinical cases of *C. auris* in Nebraska.
 - ii. Labs are advised that some identification systems might misidentify *C. auris* ([see attached](#)).
 - iii. Laboratories should submit suspected or confirmed isolates of *C. auris* to the NPHL.
 - iv. The CDC has provided [recommendations](#) when working with suspected or confirmed *C. auris* in the laboratory.
 - 1. Including an [EPA-approved list of disinfectants](#)
 - v. The NE-DHHS has approved colonization screening in different facilities around the state. This Testing is being done at the regional laboratory in Minnesota should you receive a call about the results.
- d. The exceptions list for possible carbapenem-producing organisms has been expanded to include *Klebsiella aerogenes*, which are non-susceptible to imipenem but susceptible to ertapenem and meropenem.
 - i. This is the same rule for *Proteus spp.*, *Providencia spp.*, and *Morganella morganii*.
 - ii. The [supplemental form](#) and the [submission guidelines](#) have been edited to reflect this change.

2. DHHS Section updates:

- a. Please refer to the DHHS Weekly Surveillance Report for up-to-date information on influenza and other respiratory diseases.
- b. A dairy worker in Texas tested positive for highly pathogenic avian influenza (HPAI) A(H5N1).
 - i. **Notify DHHS for positive influenza A detection with no sub-type.**
 - ii. **Forward specimens to NPHL.**
- c. There has been an increase in positive norovirus testing at Bryan LGH in Lincoln.
