

**"Laura's Lean Beef Giveaway" Sweepstakes**  
**Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes an entrant's full and unconditional agreement to and acceptance of these Official Rules. Laura's Lean Beef Giveaway Sweepstakes (the "Sweepstakes") begins at 8:00 a.m., Eastern Time ("ET") May 21, 2025 and ends at 11:59 p.m. ET on September 1, 2025 ("Sweepstakes Period"). The Sweepstakes is sponsored by Meyer Foods Group LLC, d/b/a Meyer Natural Foods (the "Sponsor"), 1990 Rocky Mountain Ave., Loveland, CO, 80538.

**ELIGIBILITY:** The Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia who has the age of majority in his or her state or territory of residence and as of the Sweepstakes start date. Employees, officers and representatives of the Sponsor, their parents, affiliates, subsidiaries, agents, advertising and promotion agencies, Dansons, Inc. ("Prize Provider") and American Sweepstakes & Promotion Co. Inc. **HOW TO ENTER:** During the Sweepstakes Period eligible participants are invited to participate by visiting the Sponsor's website at <https://www.laurasleanbeef.com/> (the "Website"). Once on the Sweepstakes web page the Entrant needs to fill in and submit the required fields on the entry form including their first and last name, email address and zip code to receive one (1) Sweepstakes entry. Participants must also opt in to receive Laura's Lean newsletter in order to receive weekly signup opportunities. Participants will also have the opportunity to gain two (2) additional entries by answering a couple of questions on the entry form. In addition, there will be weekly ways to gain additional entries by answering a few questions that will be posted in the Sponsor's newsletter. A maximum number of 28 entries will be offered throughout the sweepstakes period.

**Limit one (1) entry per person, per email address.** Participants should submit an entry using an email address subscribed to and registered in their name. Once submitted an entry cannot be deleted, canceled or modified. The potential Grand Prize winner will each be notified by the email address that they included on their entry form.

**PRIZE:** Ten (10) Grand Prize winners will each receive one \$11 voucher a week for Laura's Lean Beef for a year, a total of 52 weeks. The Approximate Retail Value of the prize is \$572. Total Prize Pool ARV is \$5,720. Vouchers will begin sent out monthly starting January, 2026. In the instance that Laura's Lean Beef is not available in the winner's area, the Sponsor will ship the winner Laura's Lean Beef directly from their ecomm store, Meyer Company Market, quarterly (4) shipments per year.
