## **Comments:**

Pledge Offerings at \$7,925 were under Budget for the month by \$(6,827) while year-to-date Pledge offerings continue significantly over Budget by \$30,193 resulting from \$42,000 in pre-paid pledges in January.

Clergy expense was over Budget for the month by \$1,442 with a third paycheck for the vicar paid in April. Facilities Costs were under Budget by \$(8,068) for the month without the Gateway rent expense. Total Expenses for the month were Under Budget by \$(5,094). Year-to-date Expenses were over Budget by \$44,701 with some costs saving now offsetting the \$55,000 Lease Buyout. There was a \$2,185 streaming expense in April for a upgraded camera and two wireless mics.

Investment changes continue to have a significant impact on Income with a \$5,686 Gain for April and a Gain of \$\$13,860 for the first four months.
