1. Title: the title should define the scope of the study	
2. Introduction/Background: <ul style="list-style-type: none"> a. Incidence and prevalence of the problem b. Gap in the literature c. Define the purpose (You only need 2-3 purpose statements) 	
3. Methods: <ul style="list-style-type: none"> a. A literature review was completed 2010 through 2015 using ___ databases called,___,___,___, and ___. b. List key search terms c. List inclusion and exclusion criteria d. Descriptive Study, T-Test, Meta-Analysis or other research methodology e. Clinical Descriptors: Epidemiology, Pathophysiology, etc 	
4. Results: <ul style="list-style-type: none"> a. Describe the number hits you received in each database. b. Describe the number of hits that met inclusion criteria c. Provide a table with articles meeting inclusion criteria (provide author name, year, and findings) d. Present scholarly data in an interesting format and in a clear and easily understandable manner for most clinicians at varying levels of academia. e. Provide clinical pearls that will help clinician provide current, competent, evidenced based care. All pictures, tables, instruments should be appropriate for the question, related to study, and enhance the content. 	
5. Conclusions: 3-4 supporting key points. Make sure your conclusion is related to your purpose statement	
6. Implications for Practice: Make sure your implications for practice are related to the purpose statement

Good use of color, but usually not more than 3-4 colors. 2. Organization of poster allows viewer to easily navigate through presentation. Sequence of poster is logical 3. The impression is engaging and entices viewer to stop and view poster; imaginative aspects 4. A person should be able to view your poster standing at a distance at least 3 feet away. 5. General font rules: <ul style="list-style-type: none"> Title 96 pt. Authors 72 pt. Affiliations 36-48 pt. Section Headers 32. Text 24 pt. References 18 pt. 6. Acceptable Font Type: Tahoma, Helvetica, Palatino, Arial, Times New Roman
