### **Re-Verification Overview**

*Thursday, April 24, 2025, 1:00 p.m. – 3:00 p.m.*

This course serves as a refresher for the steps taken by the provider to complete the Re-Verification process through NCTracks. It also covers the steps to enter information and submit a Manage Change Request (MCR) in the event the user is prompted to complete an MCR during Re-Verification/Re-Credentialing. The terms Re-Credentialing and Re-Verification are used interchangeably in NCTracks. At the end of training, you will be able to:

- Explain what provider Re-Verification is all about and why it is required.
- Explain each phase of Re-Verification.
- Complete the Re-Verification process in NCTracks.
