### TODAY'S PROGRAM... *Child & Family Life at C.S. Mott Children's Hospital*

**Larry French** introduced Lindsay Heering, Administrative Director, and **J. J. Bouchard**, Patient Technology Coordinator, both of Child & Family Life at the C.S. Mott Children's Hospital. In his introduction, Larry remarked that our Club and Foundation have actively associated with Child & Family Life for 98 years, and, as Lindsay began her remarks, she expressed gratitude, describing our Kiwanis support as a cornerstone for this program, the first of its type established anywhere in the world.

Lindsay surveyed the many services provided by the 70 member staff of Child & Family Life, ranging from the "MR-I Can Do It" approach that uses sounds and activities to capture the attention of young patients during radiology services (thus eliminating the need for sedation) to a variety of art and music therapy techniques. We were shown a moving video of 8-year-old Evie Hurst, who is totally blind but who had the courage to sing a beautiful solo accompanied by guitar while receiving seizure treatment. Next month, a groundbreaking will occur for a "Sophie's Place" to establish a recording studio in Child & Life where young patients can record their own musical videos. Lindsay described heartbeat therapies, through which young patients receiving heart transplants can use the beating rhythms of their old and new hearts, layered with music they like, as they create their own musical recordings.

J. J. described his role as integrating technology with everyday hospital practices to help give Mott patients the medical care they need. For example, J. J. described how Pokémon Go is used as a sneaky way to get patients to exercise. Each patient room has an Xbox, allowing game playing with other kids anywhere in the world and reducing patient isolation. The Mott Arcade features virtual reality games, tons of Legos and lots of Mario games. J. J. showed a video of Jacob's Story, a deaf patient with cancer and other medical issues who communicates with the help of special technology. Jacob's Story may be seen by clicking the link below, and J. J.'s personal story is the following link. J. J. was treated at Mott for Type 1 diabetes 31 years ago, and his only remaining memory of that experience is playing his first video game while hospitalized.

When **Pam Conway** began volunteering for Kiwanis on January 2, 2019, our "sewing area" located in room 1000 just outside the conference room needed a dedicated leader. Pam took charge of this area, to be joined by **Cheryl Vogel** in September 2019. Over the past year, the display area has doubled, thanks to some shelving from the former Carson's store in Howell. Now the fabric pieces are attractively displayed on the wall behind the table and all sorts of other sewing related items—patterns, books, etc., along with a new section of upholstery fabrics—are on the new shelves on the side wall. Sewing machines for sale are located here, too.

Not only has the display of merchandise been vastly enlarged and improved, but Pam is often there on sale days to answer customer questions and even provide some instruction when asked.

While these are very rough figures, sewing related sales, shown as part of "crafts", have increased from 1,236 items and \$1,486 for the quarter ended 12/31/18 to 2,146 items and \$2,822 for the quarter ended 12/31/19. A 100% increase in dollars!
